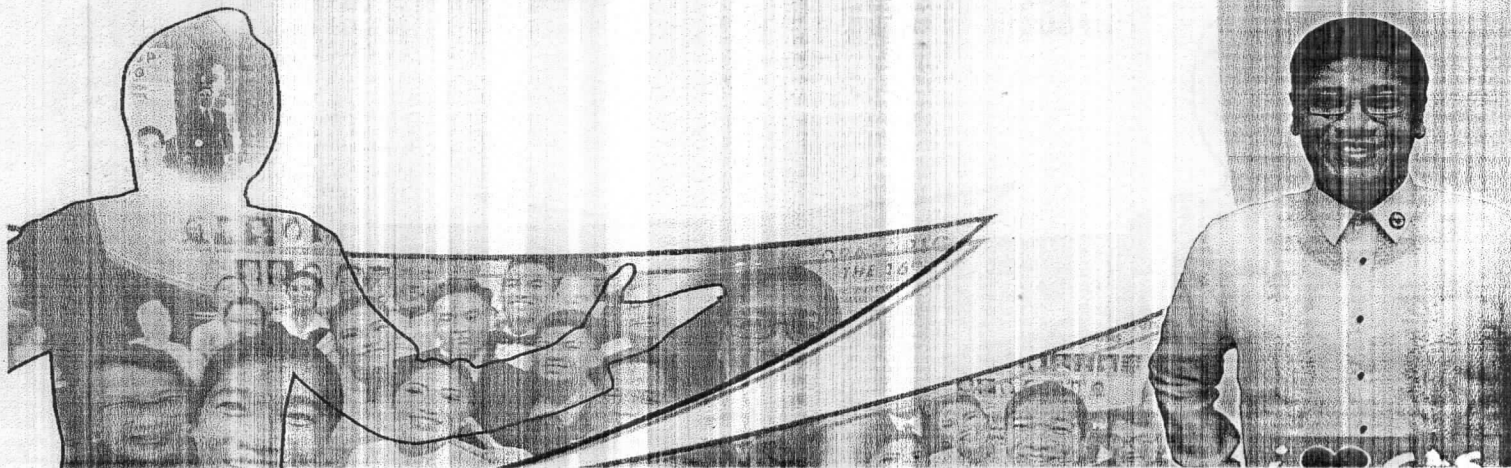

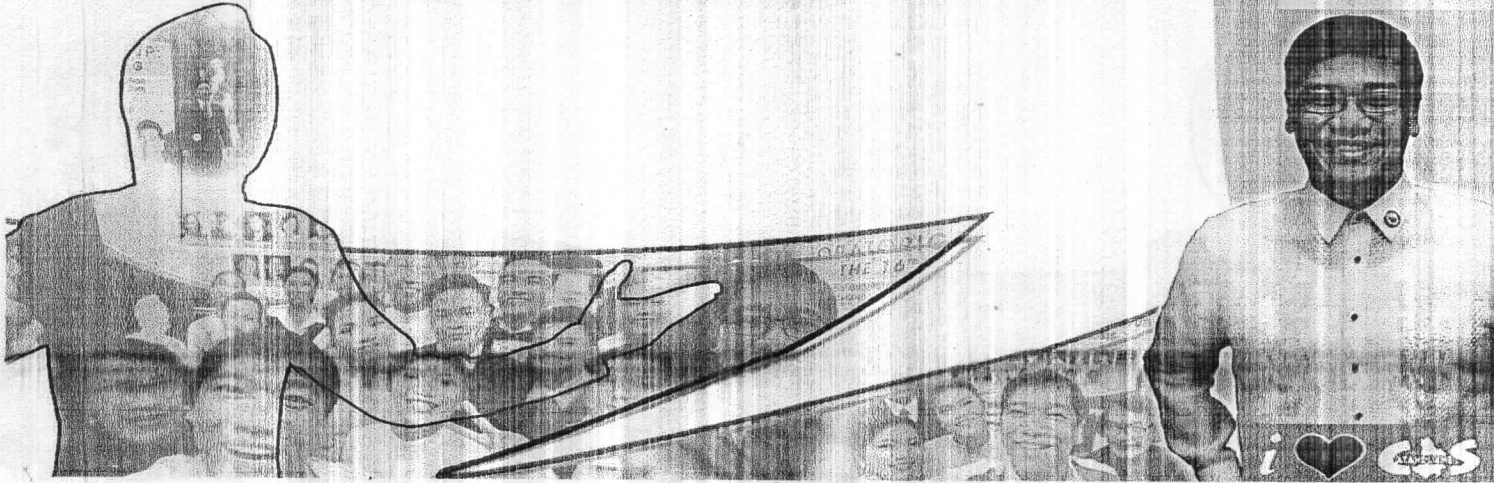
Greetings!

It is with pleasure to inform you that Atty. Cesar V. Sarmiento, former Congressman of the Lone District of Catanduanes, will again sponsor the **CS Oratorical Cup**, a yearly contest for high school students in the province. This will be its **19th staging** as it has been started and held annually since 2001. We would thus like once again to respectfully request your good office to approve its inclusion in the calendar of events for our high schools in Catanduanes these last few months of SY 2019-2020.

Our invitation will be for secondary institutions, including private, to have their school and municipal eliminations until the third week of February 2020 and for municipal contestants and their coaches to submit the required oratorical pieces, pictures, etc., a week or two prior to the Cup, which we plan to hold last week of February or first week of March 2020.

For this staging, the organizing committee has chosen this topic: **Fake News, Lies, and Other Social Media Abuses, How Should We Deal With Them?**

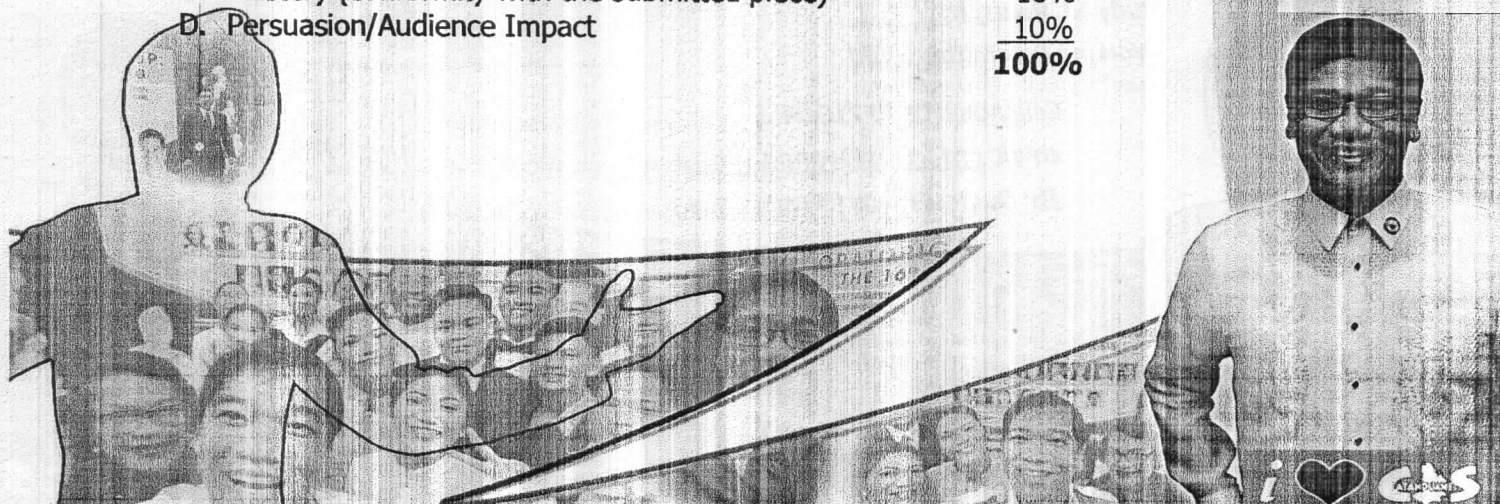
GUIDELINES:

1. The Oratorical Cup is open to all bona fide high school students in the province, with the exception of those who have already competed and won as champion of previous Ora Cup stagings.
2. The oratorical piece shall be on the topic: **"Fake News, Lies, and Other Social Media Abuses, How Should We Deal With Them?"**
3. Oratorical pieces are required to be submitted to the Working Committee via email. A contest piece should contain no more than one thousand (1,000) words (content only) to qualify for the best oratorical piece. Once submitted, a piece can no longer be altered for delivery or oratory purpose.
4. The criteria for judging for the **Best Oratorical Piece** are as follows:

A. Relevance to the theme	40%
B. Organization	30%
C. Style	30%
	100%
5. The **Best Oratorical Piece** shall be awarded P3,000.00, plus a certificate.
6. During the Cup proper, attire of the contestants shall be semi-formal. No school uniform is allowed.
7. Participants shall be defined by numbers, to be determined through drawing of lots at the start of the competition.
8. The following are the delivery criteria for judging for the **Best Orators**:

A. What is heard	40%
1. <i>Voice</i>	20%
<i>(audibility, emphasis, quality)</i>	
2. <i>Pronunciation</i>	20%
<i>(enunciation, accent, clarity, phrasing)</i>	
B. What is seen	40%
1. <i>Stage Deportment</i>	20%
<i>(facial expressions, gestures, body movements)</i>	
2. <i>Poise and Posture</i>	20%
C. Mastery (conformity with the submitted piece)	10%
D. Persuasion/Audience Impact	10%

9. Delivery of the submitted piece shall be from five (5) to seven (7) minutes only. Excess in time delivery shall have the following point deductions:

- Inside 30 seconds after 7 minutes 2 pts.
- 31 seconds to 1 minute 3 pts.
- More than 1 minute 4 pts.
- More than 2 minutes 5 pts.

10. Winning participants shall receive trophies, certificates, and the following cash prizes:

	<u>Contestant</u>	<u>Coach</u>
- Best Orator	PhP 10,000.00	PhP 4,000.00
- First Runner-Up	PhP 7,000.00	PhP 3,000.00
- Second Runner-Up	PhP 5,000.00	PhP 2,000.00

11. Non-winning contestants and their coaches shall each receive Certificate of Participation and PhP1,000.00 as token of appreciation.

12. There shall also be adjudged the **Ora Cup Champion School** and this shall be based on the submitted Ora piece and the performance of the school orator or contestant:

- Ora Piece/Content	30%
- Oratory/Delivery	70%

13. The **Ora Cup Champion School** shall receive a special trophy, certificate and a cash prize of P5,000.00.

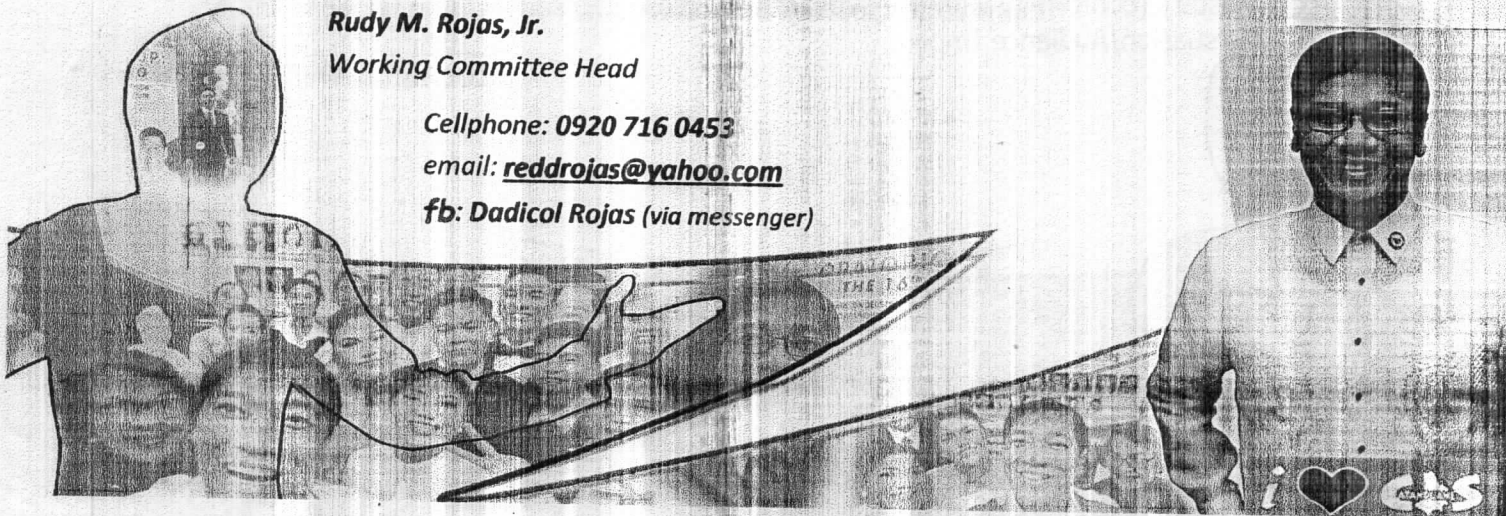
14. All participating schools shall be given Certificates of Appreciation.
