

INVITATION TO BID

CY 2014 Basic Educational Facilities Fund (BEFF) PROVISION OF SCHOOL FURNITURE To Newly Constructed Classrooms

- 1. The *DepEd*, *Division of Catanduanes*, through the *General Appropriation Act* (GAA) CY 2014 intends to apply the sum of Two Hundred Thirteen Thousand Pesos Only (Php213,000.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of *Provision of School Furniture* (Batch 3) to newly constructed classrooms. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DepEd, Division of Catanduanes now invites bids for CY 2014 Basic Educational Facilities Fund (BEFF) Provision of School Furniture to Newly Constructed Classrooms. Delivery of the Goods is required 60 days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 4. Interested bidders may obtain further information from *DepEd*, *Division of Catanduanes* and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 PM.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from <u>April 23 to May 11, 2015</u> from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Hundred Pesos Only (<u>Php500.00</u>).
- 6. The DepEd, Division of Catanduanes will hold a *Pre-Bid Conference* on *April* 30, 2015 at 2:30 o'clock P.M. at the office of the OIC, Assistant Schools Division Superintendent, which shall be open to all interested parties.
- 7. Bids must be delivered to the address below on or before <u>May 11, 2015 at 2:00</u> <u>o'clock PM at DO Conference Hall C</u>. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on <u>May 11, 2015</u> at <u>2:00 o'clock PM at the DO Conference</u>

 <u>Hall C</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. Prior to Bid Opening, representative of bidders should present and submit to the BAC a Special Power of Attorney stating the detailed activities which he/she will perform relative to the bidding at hand.
- 9. The **DepEd, Division of Catanduanes**, reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
