REITERATION ON THE AMENDMENT TO DEPED ORDER NO. 30 S. 2020 (AMENDMENT TO DEPED ORDER NO. 07 S. 2020, SCHOOL CALENDAR AND ACTIVITIES FOR SCHOOL YEAR 2020-2021)

Public Schools District Supervisors/In-Charge of Districts

- The field is hereby advised on the issuance of DepEd Order No. 12 s. 2021 released on March 2, 2021 re: Amendment to DepEd Order No. 30 s. 2020 (Amendment to DepEd Order No. 07 s. 2020, School Calendar and Activities for School Year 2020-2021) which will be followed by this division.
- 2. The following amendments are highlighted:
 - a. From March 1 to March 12, 2021, schools shall conduct intervention and remediation activities based on the unique needs of learners as determined through the results of the different forms of assessments administered for the past two quarters. These intervention and remediation activities shall be indicated in the two-week home learning plan to be prepared by the teachers, with the assistance of the assigned learning support aides (LSAs) as applicable.
 - From March 15 to March 19, 2021, teachers shall attend a professional development program through an In-Service Training (INSET) organized by the school or other relevant units of DepEd.
 - c. The schedule for the succeeding quarters shall be adjusted as follows:
 - Quarter 3 shall be from March 22, 2021 to May 15, 2021
 - Quarter 4 shall be from May 17, 2021 to July 10, 2021
 - d. The additional two-week period shall be compensated by a similar adjustment in the school break between SY 2020-2021 and by SY 2021-2022.
- 3. Immediate dissemination of and strict compliance with this Memorandum is directed.
