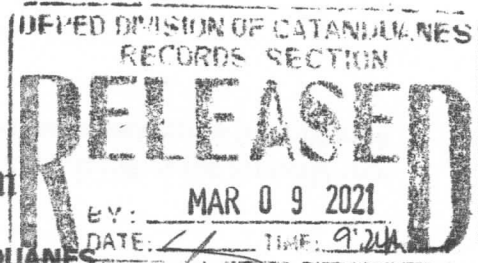

DIVISION KINDERGARTEN BENCHMARKING ACTIVITIES IN THE EFFECTIVE DELIVERY OF INSTRUCTIONS IN TIME OF PANDEMIC

1. The Covid-19 pandemic has created numerous challenges for students, educators, parents most especially the kindergarten learners. These challenges could lead to decrease in the performance and achievements of our most at-risk populations that is the youngest learners. Hence, we need to provide benchmarking activities to sustain the effective delivery of instructions to our kindergarten learners.
2. The shift in school setting, the dependency on technology for most instructional delivery were taken into consideration by the schools in preparing their school Learning Continuity Plan (LCP).
3. To better know how every school has adopted to this new normal, this Office thru the Curriculum Implementation Division (CID) will hold a One-Day Division Benchmarking activity dubbed as "**Juander K-Teacher**" in both public and private kindergarten schools on **March 26, 2021 (Friday)** at a venue to be announced later.
4. The activity aims to showcase the outside the box strategies which are considered best practices of the schools that cater the effective delivery of instructions to these youngest learners in this difficult time. Secondly, to share the contextualized programs and projects to other schools and districts for replication and modification.
5. The participants to this activity are the EPSs, PSDSs, district kindergarten key teachers, and the kindergarten teacher- presenters. Each district will send one (1) kindergarten teacher while the private school will be given two (2) slots only to present their best practices in teaching remotely the kindergarten learners. In the event that the district kindergarten key teacher is the presenter, the district kindergarten key school head will attend the said activity.



6. Teacher- presenters are advised to prepare a 10-minute video presentation highlighting the best practices of the school in addressing the remote teaching- learning of the kindergarten pupils while building relationship with parents and guardians.
