DIVISION TRAINING ON CONTINUOUS IMPROVEMENT

- 1. The Department of Education continues to decentralize its decision-making powers at different levels of governance to ensure that challenges are addressed and solved where this occur. One of the current programs/thrust of the present administration to empower its frontline service unit is the Continuous Improvement Program (CIP).
- 2. Corollary to this, the Schools Division Office of Catanduanes is holding a **Division Training on Continuous Improvement** on **March 15 to 17, 2022** at a venue to be announce later.
- 3. This training aims to:
 - a. provide the participants with understanding of the Basic CI principles, tools and methods and how these can be applied in School Improvement Plan (SIP) context:
 - b. understand the process management, translating learner needs to process Key Performance Indicators (KPIs), mapping and implementing the process that will achieve Key Performance (KP) targets;
 - c. identify priority school processes for CI project initiatives;
 - d. understand the "Triple A" process Improvement Methodology and project

documentation (A3 Document);

- e. apply process simplification and visual management in improving process;
- f. apply project management principles in preparing for implementation plan;
- g. prepare change management plan;
- h. rekindle the participant's personal commitment to the challenge of DepEd vision and mission; and
- i. clarify how the CI programme supports the broader DepEd reforms especially with regards to the School Based Management (SBM).
