# DIVISION ONLINE ORIENTATION ON THE ADMINISTRATION OF NATIONAL LEARNING CAMP ASSESSMENT (NLCA)

- 1. Pursuant to DepEd Order No. 3. s. 2024, the Bureau of Education Assessment (BEA) shall administer the National Learning Camp Assessment (NLCA) to all enrolled Grades 7 to 10 learners from all public schools across the country which intends to determine the effectiveness of the learning camp intervention on the learning proficiencies of participating learners before and after attending the said program.
- 2. NLCA is an online assessment using the DepEd LMS Moodle Platform which covers learning areas in English, Science, and Mathematics which shall be administered in testing centers compliant with the technical requirements and specifications set by the DepEd-Central Office on the following dates:

Grade Level	Activity	Testing Window
7 & 8	Pre-Test	March 11-April 12, 2024
9 & 10	- "	April 15-May 17, 2024

2. Relative to this, secondary schools are advised to ensure that all target test takers have their respective DepEd Microsoft Account which will be used to register and log in to the learning management system (LMS) and ensure that the Testing Centers(preferably E-classrooms) and devices to be used during the 2023 NLCA must be ready before the said assessment. Service credits will be granted to the School ICT Coordinators and other employees involved in the preparation of the testing centers(e-classrooms) and devices during Saturdays and Sundays. For other IT related concerns (MS 365 of learner's templates) will be communicated through the Teams group of School ICT Coordinators.
