

1. This Office congratulates the PASSERS of the Philippine Educational Placement Test (PEPT) conducted last November 18, 2018 at Catanduanes National High School, Virac, Catanduanes.
2. Ratings per subject area are indicated in the Certificate of Rating (COR) attached in this Memorandum.
3. The school head or the guidance counselor shall get/receive the Certificate of Rating (COR) of the students to Sarah S. Chiong, SEPS- Division Testing Coordinator at the SGOD Office.
4. Pursuant to DepEd Order No. 49, s, 2013 entitled **Effectivity of the Grade/Year Level Placement of Philippine Educational Placement Test (PEPT) Qualifiers**, the following are the guidelines:
 - a. The placement of the PEPT qualifiers (who took the November Regular, Special and walk-in Examinations in the Division Offices) shall take effect in the next or

subsequent school year, not during the current school year (SY) when the test was administered.

- b. On the other hand, the placement of the June 12 PEPT qualifiers shall take effect in the same or current SY when the test was conducted. (The June 12 PEPT is administered for free in celebration of the Philippine Independence Day.)
- c. Moreover, the following data are to be indicated in Forms 137 and 138 of the PEPT qualifiers should they enroll in school:

"Placed/Reclassified in _____ on the basis of the PEPT results (Grade/Year Level)
dated _____ with Examination No. _____." (Date of Examination)

- d. In addition, the PEPT Certificate of Ratings (COR) should be attached to Forms 137 and 138 of the PEPT qualifiers for reference.
5. Attached are the names of PEPT passers with grade/year level where they have met the basic academic requirements.
 6. Furthermore, this Office informs the field that the June 12 Special PEPT is administered for free in celebration of the Philippine Independence Day.
 7. Public Schools District Supervisors and School Heads are advised to encourage our over- aged pupils/students to apply and take the test.
 8. Requirements for PEPT:
 - a. PEPT Form I (Registration Form) – available on the 1st week of May, 2019.
 - b. Birth/Baptismal Certificate (certified true copy)
 - c. School Records- Forms 137 and 138 (certified true copy)
 - d. Two (2) recent 1"x1" ID pictures- identical and not scanned
 9. For immediate dissemination and compliance.
