CONDUCT OF TRAINING AND PACKET TOURNAMENTS FOR SWIMMING, GYMNASTICS, AND BOXING

To:

- 1. In connection with the conduct of Modified Palarong Bicol on April 23-28, 2023, this office shall conduct 3-day refresher course training for teachers who wish to coach in swimming, gymnastics, and boxing scheduled on March 25, 26, and April 1, 2023.
- 2. In addition, there will be a packet tournament in **swimming for secondary students**, **gymnastics for elementary and high school learners**, **and boxing for secondary students on March 26**, **2023**, in a venue to be announced in a separate advisory. It is suggested that the teachers who will attend the refresher course should be the coaches of the learners who will participate in the packet tournament. Parental consent is a requirement in this activity. No pupil or student shall be allowed to play without parental consent.
- 3. The champions in the three sports events shall represent the province in the Modified Palarong Bikol 2023.
- 4. The officiating officials and technical working groups of the three (3) sports events are requested to report in the Division Office on **March 23, 2023, at 1:00 in the afternoon** to prepare the necessary logistics. (Please see attached list for reference).
- 5. Teachers and non-teaching personnel shall be given service credits or compensatory time-off (CTO) whichever applies for services rendered on weekends and or extra hours rendered on weekdays, in compliance with the guidelines on the grant of service credits/compensatory time-off.

- 6. The travel and other related expenses to be incurred by the teachers' and students' participation in this activity may be charged from the school mooe/municipal SEF, donations, sponsors, and partnership, while meals of the officiating Officials shall be borne from the Provincial Special Education Fund subject to the usual accounting and auditing rules and regulations.
