
This activity on School Land Issues and Proposed Solutions will initially cover the following subject matters.

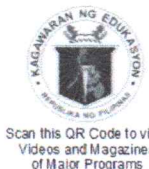
