- 1. - 4. To promote co-ownership of the project, **Public Schools District Supervisors** and **School Heads** of the schools involved will have a **virtual orientation** on **April 26, 2022** via Google Meet. The link will be sent through messenger.
- 5. Since this activity will be done even during Saturdays and Sundays, **service credits** will be granted to teachers who will render services for the above-stated activities in accordance with DepEd Order 53, s. 2003 entitled Granting of Service Credits to Teachers.
