NATIONAL HERITAGE MONTH CELEBRATION 2021

TO:

Education Program Supervisors Public Schools District Supervisors Heads of Public and Private Schools

All Concerned

- 1. Cognizant with Memorandum, DM-OUF-2021-0222) on National Heritage Month and by virtue of Presidential Proclamation No. 439, s. 2003, declaring the month of May as the Month of Traditional Festivities and the Month of People's Participation in the Preservation of Filipino Heritage, and as per RM No. 37, s. 2021, a Regional Heritage Month celebration through the Curriculum and Learning Management Division (CLMD) shall be conducted on May 24-31, 2021, with the theme: "VICTORY AND HUMANITY: Upholding Filipino Heritage and Identity."
- 2. The week-long activity has the following objectives:
- a. reinforce advocacy of caring and upholding both tangible and intangible local heritage in this time of pandemic;
- b. recognize the value of Philippine Cultural Heritage by participating in events relative to the National Heritage Month and the Quincentennial Commemorations of the Philippines (QCP); and
- c. develop among the teachers and learners appreciation on Bicol arts, art and Cultural Heritage through performances, competitions, and workshops and symposiums.
- 3. The Regional Celebration shall have an online competitions on Digital Poster, Tigsikan and Vocal Solo that focuses on the rich Cultural Heritage of Bicol. The competition shall be participated in by teachers from either public or private schools scheduled on May 24, 2021. It shall also be highlighted by a virtual exhibit on the Deped Gabaldon school buildings and a symposium relevant to the theme. The details about the symposium shall be communicated through an Advisory.
- 4. In preparation for the regional celebration, the Division opted to identify the following participants as entries for the different events due to time constraint:

It is understood that health and safety protocols per IATF standards shall be strictly observed during the preparations and conduct of the activities.
- Relevant to the celebration of the above activity, every school are also encouraged to have their own activities regarding the month celebration. For other details of the month celebration, please refer to the Regional Memorandum No. 37 s. 2021.
