1. In compliance with the Regional Memorandum No. 96 S. 2018 entitled **15<sup>th</sup> Regional Alternative Learning System Out of School Youths/Adults (ALS-OSYs/OSAs) Encampment** scheduled on **August 27-31, 2018** at **Naga City Sports Complex, Pacol, Naga City** with its theme: **"ALS K to 12 Learners Handa sa Pagharap sa Harmon ng Buhay"**, this Division through the **Alternative Learning System** will send a minimum of fifty (50) Out-of-School Youths/Adults and ALS Teachers.

2. Interested stakeholders are encouraged to participate in the said activity, provided they are endorsed by their respective heads of organizations.

3. The encampment aims to:

- a. Equip the OSY with life skills (LS) and lifelong learning (LL) necessary to become effective, efficient and responsive citizens.
- b. Strengthen the OSY/OSA spiritual and moral values.
- c. Develop self-reliant, dynamic and creative leaders to become effective catalysts/agents of change.

4. Registration fee of Three Thousand, three hundred twenty-five pesos (Php 3,325.00) shall be charged from each participant/camper to defray the expenses broken down as follows:

Camp Registration	- Php	750.00
Meals/food for 7 days	-	1,750.00
Transportation/term. fee	-	825.00

5. The expenses to be incurred by each participant/camper shall be charged against Division MOOE/SEF/LGU/GAD/ALS Funds subject to the usual accounting and auditing rules and regulations.
