1. Relative to OU-LAPP No. 645, s. 2019, on the Use of DepEd Partnerships Database System (DPDS) in Reporting Partnership Engagement, the Adopt-a-School Program (ASP) monthly report shall be due every 5th of the month.

4. If the school has no donations received within the reporting month, it is expected that the school head shall submit a **Certification of No Donations Received** to this Office thru the SGOD-Social Mobilization and Networking Unit **on or before the last day of the reporting month**.
5. School Heads need to submit the hard copy of the Transmittal Report to the District Office thru the designated District Partnerships Focal Person and he/she shall then forward it to this Office thru the SGOD-SocMobNet Unit, after the DPDS report for the month has been uploaded.
