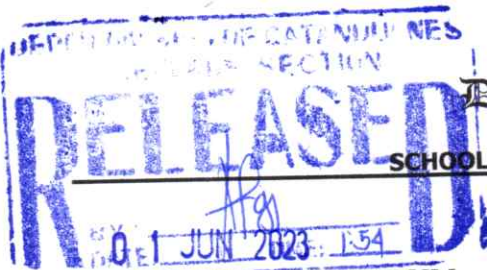

CRITIQUING AND VALIDATION OF SHS NUMERACY ASSESSMENT TOOLS

To : Schools Division Superintendents

1. In order to refine the Senior High School Numeracy Assessment Tools developed by the Mathematics teacher-writers and content editors last April 28 – 30, 2023, DepEd Region V, through the Curriculum and Learning Management Division will conduct the Critiquing and Validation of the Senior High School Numeracy Assessment Tools on June 6 – 9, 2023 in a venue to be announced later.

2. The activity aims to:
 a. address concerns on content of the test items developed;
 b. check for language issues on the test items, and;
 c. come up with a refined and enhanced numeracy assessment tools for senior high school.

On the other hand, the 104 select Mathematics teacher-writers and 13 Division Mathematics Supervisors/coordinators will participate remotely.

4. On-site participants are expected to arrive at the venue in the afternoon of June 5, 2023 for Batch 1 and afternoon of June 7, 2023 for Batch 2. The identified members of the technical working group and support staff will have an orientation conference at 4:00 o'clock in the afternoon at the session hall of the venue on the same dates. The first meal to be served for on-site participants is dinner on June 5, 2023 for Batch 1 and June 7, 2023 for Batch 2, while the last meal is afternoon snacks on June 7, 2023 for Batch 1 and June 9, 2023 for Batch 2.
5. Participants are expected to be present and actively participate in the entire duration of the activity and are advised to bring individual **laptop, extension cord and USB/hard drive** to be used during the activity. Considering that the 104 select Mathematics teacher-writers as well as the 13 Division Mathematics Supervisors/Coordinators will participate remotely, the latter should arrange for a safe and accessible venue with reliable internet connection to ensure that they can effectively participate throughout the duration of the activity.
6. Meals and accommodation of the participants who will be at the venue as well as supplies, tokens and/or honorarium of non-DepEd validators and other incidental expenses relative to this regional activity shall be charged against FLO (Continuing) Fund for FY 2022, while transportation and other incidental expenses of the participants, support and training staff both those who will be on-site and off-site shall be charged against respective local funds/ MOOE subject to the usual accounting and auditing rules and regulations.
7. Those who will be involved in the activity shall observe the minimum health protocols as required by the IATF.
8. The Activity Matrix and list of the Regional Working Committees are enclosed in this Memorandum.
9. Immediate dissemination of this Memorandum is desired.
