

We, from Save the Children Philippines, are very grateful for your continued support to implement the Education Safe from Disasters Project: Developing an Ecosystem for Comprehensive School Safety in the Philippines, with the support of Prudence Foundation. Now on its third year of implementation, we expanded our coverage from region III to region V for our rollout areas which was started last February 2023.

About 5 months ago, Save the Children Philippines has carried out many activities in 30 pilot schools from the 13 divisions in Region V with the support of the Division DRR Coordinators.
