1. In support of the Unnumbered Regional Memorandum dated October 13, 2020, RE: FEEDBACK REPORTING ON THE UTILIZATION OF THE REGIONALLY INITIATED SELF-LEARNING MODULES and QUA MEMO 00-1020-0138, entitled, DEPED ERROR WATCH INITIATIVE, dated October 12, 2020, the following guidelines are to be observed by schools:

a. Feedback from learners, parents and teachers on the utilization of SLMs locally developed and Central Office provided shall be channeled to the school heads using feedback forms or through electronic means via links

or through electronic means via links.

b. Received queries and reports shall be subjected to verification and be given appropriate action.

c. School QA Teams shall review the reports/findings on the content of SLMs using the attached template.

d. SLM content findings and recommendations shall be directed immediately to the concerned Learning Area Supervisors.

e. Learning Area Supervisors shall forward all submitted feedbacks to LRMDS for consolidation and submission to the Regional Office.

f. Posting of findings/error in the social media is highly discouraged. DepEd teachers and other personnel are enjoined to recommend for improvement of any criterion especially in the SLM through their school heads.

g. Additional items for modification, correction, clarifications or additional instructions in any part of SLM as needed in a form of Learning Activity Sheet/Worksheet with clear instructions/directions shall be attached to the modules to be delivered to the learners.

h. For Quarter 2 SLMs, Learning Area Supervisors will conduct content review with their respective Division Quality Assurance Teams. They will be submitting Matrix of Correction, if applicable, to the Regional LRMDS through the Division LRMDS before the distribution for printing. Sample of Matrix of Correction will be provided by the LRMDS through the PDO.

2. In relation to this, schools are requested to submit **teachers' or parent-facilitators' 10 frequently asked questions** about Self-Learning Modules. This request will be submitted not later than Friday 12 noon of October 16, 2020 through <u>peachieroshele.chavez@deped.gov.ph</u> for consolidation and to be forwarded to the region.


