1. Pursuant to DepEd order No. 7 s, 2015 entitled Hiring Guidelines for Teacher 1 Positions Effective School Year (SY) 2015-2016, the recruitment and selection of Teacher 1 applicants for SY 2022-2023 is scheduled on the following dates:

2. All applicants shall register to the Department's online system at <u>application.deped.gov.ph</u> where they must encode their Personal Data Sheet and select the division where they want to be ranked. Once submitted, an applicant number will be issued. This number must be indicated in the submission of the application requirements.

- 3. All applicants are required to submit the following documents to the School Selection Committee; to wit:
 - a. Letter of Intent
 - b. CSC Form 212 (Revised 2017) in two copies with the latest 2x2 ID picture
 - c. Certified photocopy of PRC professional identification card or PRC Certification showing the teacher's name, LET rating and other information recorded in the PRC office
 - d. Certified photocopy of ratings obtained in the Licensure Examination for Teachers/Professional Board Examination for Teachers
 - e. Certified copy of Transcript of Records (TOR)
 - f. Copies of service records, performance rating, and school clearance for those with teaching experience. If unavailable, the applicant must submit a justification citing the reasons for unavailability
 - g. Certificates of specialized trainings, if any
 - h. Certified copy of the voter's ID and/or any proof of residency deemed acceptable by the screening committee
 - i. NBI Clearance
 - j. Omnibus certificate of authenticity and veracity of all documents submitted, signed by the applicant
- 4. The School Screening Committee shall issue a certification to the applicants that it has received the application specifying the documents following the format attached in Enclosure No. 3.
- 5. The applicants assume full responsibility and accountability on the validity and authenticity of the documents submitted as evidenced by the Omnibus Certification of Authenticity. Any violation will automatically disqualify from the selection process
- 6. Applicants with Early Childhood Education Units should include their documents / certification of units earned.
- 7. As provided under Section 4.4.4 of DepEd Order No. 7 s. 2015, teachers who have not practiced their profession for the past five (5) years shall be required to take at least twelve (12) units in education courses, consisting of a least six (6) units of content courses.
- 8. Teacher applicants for SY 2021-2022 who would like to RETAIN their points will submit their letter of intent indicating therein the specific criteria / criterion to be retained or they may add documents identifying the criteria / criterion to be updated for additional points like teaching experience, specialized training, etc. In case the applicant has no document to be updated, they will just submit the letter of intent that they will retain all their points to be included in the latest RQA.

To facilitate the evaluation of documents, elementary school heads shall indicate in their transmittal letter the names of the applicant, the status of application whether old, updating or new. Likewise, for the secondary level,

school heads shall submit transmittal with the list of applicants by learning area or major.

- 9. Teacher applicants who served as Volunteer Teachers/Learning Support Aide shall submit their Volunteer Acknowledgement Form or Contract of Service if LGU Funded to earn points in Experience.
- 10. Elementary and secondary school heads are required to submit the Composition of the School Screening Committee as stipulated in section 6.2.1 of DepEd Order No. 7, s. 2015 to be approved by the Schools Division Superintendent. A copy shall then be submitted to the ASDS Office on or before June 15, 2022.
- 11. An orientation of the Division Selection Committee / Sub-Committee shall be held on July 7, 2022
- 12. The cut off score for inclusion in the RQA is seventy (70) points. There will be a separate RQA for Kindergarten and SPED.
