- 1. In support of Regional Memorandum No. 094, s. 2023, this Office establishes a support mechanism to **Linking Standards and Quality Practice (LiSQuP) Scholars.** LiSQuP is a Professional Development Program implemented by National Educators Academy of the Philippines in partnership with Philippine Normal University.
- 2. To fully support the scholars, the immediate superiors shall consider the following support mechanisms which may be deemed reasonable:
 - a. unload or reduce ancillary functions or coordinatorships of the scholar until the completion of course;
 - b. give the scholar a maximum of six (6) teaching hours including ancillary functions in consonance to RA 4670;
 - c. allow the scholar to leave the school after his/her class in order to prepare for the online class and academic requirements;
 - d. designate additional or temporary staff to assist scholars with administrative functions, such as, but not limited to school heads, education specialist, and supervisors; and
 - e. reimburse the internet expenses of the scholars following DepEd Order No. 30 s. 2021 and other existing guidelines subject to availability of funds and to the usual accounting and auditing rules and regulations.
- 3. Schools are reminded that LiSQuP scholars are bonded with a service obligation as stipulated in their NEAP scholarship contract based on DepEd Memorandum No. 082, s. 2020 or Guidelines on the Registration of Teachers and School Leaders for NEAP-recognized PDP and Courses.

- After a series of consultations and discussions with division focal persons, representatives from NEAP Professional Development Division, personnel from the Human Resource Development Division and LISQUP scholars in the region, this Office enjoins SDOs to establish support mechanism to supervisors, school heads and teachers enrolled in the Linking Standards and Quality Practice (LiSQuP), a Professional Development Program implemented by the National Educators Academy of the Philippines in partnership with Philippine Normal University.
- Our support to LISQUP scholars is a sound manifestation of our adherence to the DM No. 82 s. 2020, ensuring that the public-school teachers and school leaders are afforded with a wide range of programs and courses, that are NEAPrecognized, aligned to PPST and consistent with the NEAP Professional Development Framework. These scholars have been provided opportunities to advance education through LISQUP Specialized Programs leading to Masters and Doctorate Degrees.
- To fully support the scholars, the immediate superiors shall consider any of the following support mechanisms which may be deemed reasonable, to wit:
 - a. unload or reduce ancillary functions or coordinatorships of the scholar until the completion of course;

b. give the scholar a maximum of six (6) teaching hours including ancillary functions in consonance to RA 4670;

c. allow the scholar to leave the school after his/her class in order to prepare for the online class and academic requirements;

d. designate additional or temporary staff to assist scholars with administrative functions, such as, but not limited to, school heads, education specialists, and supervisors; and

- e. reimburse the internet expenses of the scholars following DepEd Order No. 30 s. 2021 and other existing guidelines subject to availability of funds and to the usual accounting and auditing rules and regulations.
- 4. SDOs may also initiate other support mechanism that would be beneficial to both scholars and their respective schools/offices.
- 5. SDOs are also reminded that the LISQUP scholars are bonded with a service obligation as stipulated in their NEAP scholarship contract based on DepEd Memorandum No. 082, s. 2020 or the Guidelines on the Registration of Teachers and School Leaders for NEAP-Recognized Professional Development Programs and Courses. Scholars are also directed to prepare, submit and implement NEAP Action Plan to be monitored by appropriate offices as stipulated in the same memorandum.
