1. In preparation for the 3<sup>rd</sup> and 4<sup>th</sup> quarters Detailed Lesson Plan in English 8 submission at the Regional Office and for the school's try out and validation, there will a Division Writeshop on the Finalization of Detailed Lesson Plan In Grade 8 English and Reading for the 3<sup>rd</sup> and 4<sup>th</sup> Quarters on **September 5-7, 2019** in a venue to be announced later.

2. The training aims to :

1. Discuss and write the appropriate content, language and strategies intended for the use of DLP in English 8.
2. Capacitate the writers with the KSAs for developing the lesson plans in English and Reading.
3. Finalize the lesson plans in grade 8 for the try out and validation in secondary schools.

3. Participants to this writeshop are the lesson plan writers and validators in English grade 8. Since September 7 falls on a Saturday, a 1 day service credit/COC will be charged each writer and validator.

4. Registration fee of P 1,050 will be charged each participant for meals (lunch) and snacks (morning and afternoon) for 3 days charged to the HRTD-CID English Funds, while travel expenses will be charged to the school's MOOE.
