SUBJECT : Division Validation /Try Out of the Regional DLP in English Grade 8 for the 3rd and 4th Quarters

DATE : September 6, 2019

1. In connection with upcoming finalization of the Regional DLP in English 8 for the 3rd and 4th quarters as stated in the regional's timeline, a Division Validation /Try Out of the Regional DLP in English Grade 8 for the 3rd and 4th Quarters will be conducted simultaneously in selected secondary schools in our division particularly in Pandan, Caramoran, Panganiban and Bagamanoc municipalities on **September 23-26, 2019**.
2. Concerned secondary school heads are advised to identify English demonstration teachers for a week's lesson. They should have the copies of the DLP a week before the try out demonstration. The said DLPs will be sent in the selected secondary schools.
2. The said validation shall consider suggestions and feedback to quality assure the Contextualized Lesson Plans in English grade 8, the DLP writers shall sit with the validators/observers for immediate suggestions and recommendations during the demonstration teaching. The Education Program Supervisor in English and school heads concerned shall monitor the conduct of the validation.
3. Validators and observers are advised to record suggestions and report at the CID the following day, **September 27, 2019** for feedback giving and consolidation of suggestions which will be sent to the DLP writers for consideration.
4. DLP writers are advised to report at the CID Office on **September 13, 2019** for submission of the final grade 8 English DLP copy. Attached are schedules of demonstration teaching in concerned secondary schools.
3. Travel and other related expenses of the DLP writers and validators shall be charged to the division/school's MOOE subject to the usual accounting rules and procedures.
