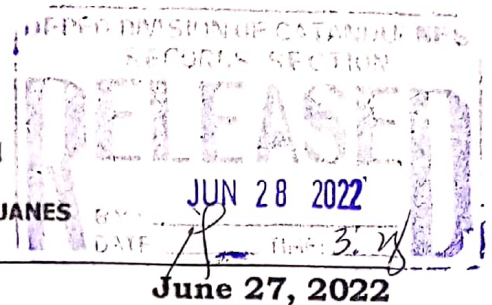

**DIVISION LIMITED FACE-TO-FACE COMPETITION IN FOOTBALL AND
FUTSAL**

1. In connection with the upcoming RASSEAE Regional Inter-Division Tournament in Football and Futsal on August 26-27, 2022 to be hosted by our Schools Division Office, Virac, Catanduanes, this office requests the schools who have a football and futsal players to compete in the said event.
2. The competing teams from each school shall be composed of the following:
 - *10 players per team*
 - *Players born in 2005*
 - *Physically Fit*
 - *Fully vaccinated and with parental consent*
3. The elimination activity shall be conducted on **July 8-10, 2022 for Futsal and on July 20-22, 2022 for Football** respectively. Expected participants in these sports events are secondary students, (male for football and female for futsal), coaches, assistant coaches, and trainers.
4. The activity aims to enhance camaraderie, goodwill, sportsmanship, discipline, teamwork, and life skills values of student-athletes inherent in their participation in sports.
5. Participating schools/teams are requested to register an amount of One Thousand pesos (**Php 1000.00**) per team, for certificates, medals, and other operational expenses of the TWG that can be charged from the PTA

Fund/donation/personal account. However, meals, travel, and other costs of the athletes and coaches shall be charged from the school MOOE/local funds subject to the usual accounting and auditing rules and regulations.

6. To ensure the safety and welfare of all the participants, parental consent from the parents of the athletes and a copy of the vaccination card shall be required during the division elimination. Minimum health protocols shall be observed at all times.
