**REGISTRATION FOR THE 2024 SPECIAL PHILIPPINE EDUCATIONAL
PLACEMENT TEST (PEPT)**

1. Corollary to DepEd Advisory dated June 5, 2024 titled "Guidelines on the Registration, Evaluation of Documentary Requirements, and Testing Centers for the 2024 Special Philippine Educational Placement Test (PEPT)", **all applications shall be accepted by the Division Testing Coordinator until July 4, 2024 at the Curriculum Implementation Division (CID) Office.**
2. PEPT is a standardized national assessment for learners under special circumstances which results will allow them to access or resume schooling and/or obtain certification or completion by grade level in the DepEd formal system.
2. The target participants are the following:
 - a. learners from school without a government permit;
 - b. learners from non-formal and informal education programs;
 - c. learners who have incomplete or no record of formal schooling;
 - d. learners with back subjects;
 - e. learners who need grade level-standards assessments; and
 - f. learners who are overage for their grade levels.
3. **No registration fee shall be collected from the test registrants.**

For new takers

1. original and one photocopy of the birth certificate duly authenticated and issued by the Philippine Statistics Authority (formerly National Statistics Office) or by the Local Civil Registrar;
2. certified true copy and one photocopy of the permanent school record (SF 10/Form 137) signed by the school principal/registrar/school administrator;
3. certificate of attendance in intervention programs or any proof of schooling (if applicable)
4. 3 identical and recently taken 1 x 1 colored ID pictures with name tags;
5. one copy of the accomplished PEPT Registration Form.

For test retakers

1. Original and one copy of the PEPT Certificate of Rating (CoR) (for applicants who need to retake the PEPT subtest);
2. Two identical and recently taken 1 x 1 colored pictures with name tags;
3. One copy of the accomplished PEPT Registration Form.

5. **Test takers whose test score in one subject is lower than 75% may be allowed to retake the failed subject within six months from the date of examination.**

6. Travel and incidental expenses incurred in this activity shall be charged to local funds/MOOE subject to the usual accounting rules and regulations.

7. Compliance to this memorandum is desired.
