OPERATIONAL GUIDELINES

I. BACKGROUND

DepEd Memorandum No. 027, s. 202 provides the guidelines on the Conduct of the K to 12 Basic Education Program End-of-School-Year Rites for School Year 2020-2021 in Light of the Covid-19 Public Health Emergency. At the local level, this is supported by Division Memorandum No. 261, s. 2021 which focuses on monitoring of such activity. With the ripples of success created by the virtual presentations to the learners and the different stakeholders, this division is holding a Division Search for 2021 Best virtual End-of-School-Year (EoSY) Rites.

II. OBJECTIVE

This activity aims to:

- a) recognize the commendable efforts of schools in coming up with best presentation for the EoSY through a contest; and
- b) provide an avenue for schools to benchmark ideas and best practices in hosting a similar virtual event.

III. SCOPE

This search is open to all public and private elementary and secondary schools in the Schools Division of Catanduanes. Schools which did not conduct EoSY rites through virtual means are excluded in this contest.

IV. CATEGORIES OF AWARDS

The search is open to all public and private schools under the following categories:

- a) Category 1: Public Kindergarten and Elementary Schools
- b) Category 2: Public Junior High School and Senior High Schools
- c) Category 3: Private Schools

V. BASIC QUALIFICATIONS AND REQUIREMENTS FOR NOMINATION

- 1. For public schools, the video must have undergone quality assurance by the authorized official from the division office.
- For both public and private schools, the video must have been presented on an online platform (facebook, facebook live, you tube, etc.). Screenshot of the presentation showing the date, time and other important details should be submitted in hard copy for this purpose.

VI. CRITERIA FOR EVALUATION

Presentation (40 %)

This includes but is not limited the use of appropriate virtual platform, timeliness, clarity of sound and images, quality speeches and messages, appropriateness of attire and gestures made in the video, formality and smooth flow of the program, with minimal errors if not perfectly done.

Compliance to DepEd and IATF Guidelines (30 %)

This includes but is not limited to full compliance to administrative issuances relative to the activity set by the DepEd and IATF.

Innovativeness (30 %)

This includes excellent and proper use of graphics, nobleness of presentation, appropriateness of effects used, among others.

IMPORTANT: Judge's decision is final and not irrevocable.

VII. SEARCH, NOMINATION AND VALIDATION PROCESS

- 1. The EPS in-charge of the quality assurance together with the PSDS shall nominate 1 entry for Category A and 1 entry for Category B for **every district**.
- 2. For Category C, every private school shall have 1 entry to be endorsed by principal.

VIII. CONFERMENT OF AWARDS

The list of winners will be released through a memorandum and will be awarded virtually during the Management Committee (ManCom) Meeting.
