3. School Feeding Coordinator and SIT School Report in their school in the schedule delivery from 8:00 am – 12:00 noon to inspect and received the food packs and immediately deliver it to the homes of the beneficiaries at 1:00pm – 5:00pm to avoid spoilage and damage.
