MECHANICS:

The DepEd and Nestlé Wellness Campus Program (the "Program") is a partnership between the Department of Education (DepEd) and Nestlé Philippines, Inc. (NPI) and will be implemented by Greatfil Team, Inc. (GTI).

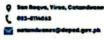
The Program will be implemented through the participating DepEd Regional Offices who will appoint the Division Supervisors or other DepEd officials to ensure that the Program will be implemented in all schools in their respective divisions in both elementary and high school levels. Division Supervisors or those appointed by the DepEd Regional Office in coordination with the Division Office will also be the contact persons in their respective divisions.

The S.Y. 2024-2025 Program implementation will give more emphasis on developing the students and parents' healthier habits through nutrition education, physical activity, and solid waste management. The Nestlé Wellness Campus Facebook Communities will serve as a platform for inter-school competitions, a repository of modules, music, and videos, and a space

for parents and teachers to share wellness ideas and practices. Additionally, webinars, cooking demos, and Nestle-sponsored activities will be conducted on these digital platforms. The implementation of the Program will be in three (3) parts, as follows:

Part 1: NUTRITION EDUCATION FOR ELEMENTARY, JUNIOR HIGH SCHOOL STUDENTS AND ADULTS (Teachers and Parents) IN ALL PUBLIC SCHOOLS IN THE EIGHT (8) PARTICIPATING REGIONS.

- NPI, in collaboration with GTI, will provide modules in the form of video content. These
 videos are encouraged to be integrated into the Elementary and High School MAPEH
 curriculum, in accordance with DepEd rules and regulations.
- Video modules will also be made available for parents, which can be utilized during PTA meetings or other face to face sessions in school. These modules aim to educate parents about the significance of good nutrition, maintaining a balanced diet, and understanding food labels.
- 3. Worksheets and activities are provided for students and/or parents to read and work on together, either at home or in the classrooms whenever feasible.
- 4. To ensure smooth program implementation, NPI, through GTI, will provide soft copies of the following materials to both division supervisors and MAPEH school coordinators:
 - 1. Lesson guides
 - Videos of the modules
 - Worksheets
 - Contest Mechanics
- For faster distribution, they may also get a copy of the materials through the GTI representatives.

Part 2: NESTLÉ WELLNESS CAMPUS DANCERCISE

- NPI, through GTI, will provide a soft copy of the official Nestlé Wellness Campus dancercise music and choreography video to each Division Supervisor in charge of the Program.
- 2. Teachers are encouraged to use the dancercise as a warm-up exercise during the flag ceremonies, during PE classes, and other related activities.

Part 3: SY 2024-2025 NESTLÉ WELLNESS CAMPUS CONTESTS AND RECOGNITION

The current school year marks the 12th year of the Nestlé Wellness Campus program. NPI, through GTI, aims to make the program more fun and exciting through different competitions, allowing students, teachers, and parents to apply the knowledge gained from the provided modules. Winners who excel in these competitions will receive well-deserved recognition, while also contributing scores that will contribute to their respective regions' success.

The competitions will have three (3) categories, namely:

- A. Inter-school Category
- B. Inter-division Category

C. Inter-region Category

A. INTER-SCHOOL CATEGORY

- 1. The inter-school category is open only to all public schools in both elementary and high school in the eight (8) participating regions namely:
 - i. National Capital Region (NCR)
 - ii. Region 4-A CALABARZON
 - iii. Region 5 Bicol Region
 - iv. Region 6 Western Visayas
 - v. Region 7 Central Visayas
 - vi. Region 8 Eastern Visayas
 - vii. Region 10 Northern Mindanao
 - viii. Region 11 Davao Region
- Schools are strongly encouraged to participate in all categories. Interested schools must submit the registration form and ensure that students have duly signed the consent waiver form to confirm their participation. The inter-school competitions are as follows:
 - i. Nestlé Wellness Campus Hataw Sayaw Year 2
 - ii. Nestlé Wellness Best Implementing Schools
 - iii. Sarap Sustansya Cook Off Competition (Junior High School only)
- Kindly refer to the attached sheets for the mechanics for each competition.
- 4. Each school is permitted to submit only one (1) entry for each competition. However, integrated schools have the opportunity to submit two entries: one (1) for the elementary level and one (1) for the junior high school level. The Sarap Sustansya Cook-off, on the other hand, is exclusively for the Junior High School level.

B. INTER-SCHOOLS DIVISION CATEGORY

The school year 2024-2025 marks the second year of the NWC Program's implementation of the inter-division competition, aimed at recognizing the Schools Division that demonstrates excellence in program implementation.

The Inter-Schools Division Category will have two levels as follows:

- Regional level
- o National level

In the regional level competition, the winner will be determined based from implementation of NWCP in the division and the performance of the schools representing the division. The winning division will be declared the Outstanding Schools Division of the Year and correspondingly the focal person assigned will be declared the "Outstanding Focal Person of the year".

In the national competition, only the division with schools representing the region to the National level competition will qualify. The top three (3) divisions will be chosen based on the program implementation and scores gained by their schools

representing the region. The division focal persons of the top three divisions will be declared the National Outstanding Division Focal Person of the Year, Firstrunner up and second runner-up respectively.

Note: Assigned DepEd Division Supervisors will ensure that those who will participate in the Program are legitimately enrolled grades 1-6 and grades 7-10 students.

In order for a region to achieve the maximum score per criteria, 100% of the schools in the region based on the list validated by the Division Supervisor in charge of the Program should be able to:

- 1. Implement the video modules for students and parents.
- 2. Implement the dancercise, whenever possible
- 3. Submit the duly signed certificates of completion.

Wellness Ambassadors from GTI, together with the duly assigned DepEd Division Supervisors will monitor the schools in their respective divisions to validate the school implementation, via actual visit or online, whichever is possible.

Validation period will be announced separately.

orderly implementation of the Program upon prior notice to the participants.



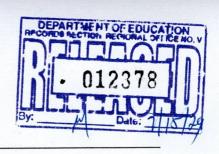

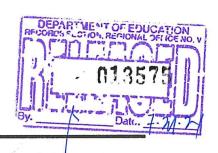

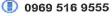

2024 NESTLÉ NEEDS YOUTH PROGRAM SPOKEN WORD POETRY COMPETITION PROGRAM MECHANICS

Activity Title: NWC Spoken Word Poetry Competition

Duration: August 1, 2024 to December 31, 2024

Coverage: Region V - BICOL for Senior High School Only

Qualifications of Participants:

1. The competition is open to all Senior High School in Region V – BICOL REGION only, represented by a team which must consist only of one (1) student in Grade 11 or 12, and one (1) coach-teacher from the school (the "Participants" / "Participating Team"). To qualify participating schools must have implemented the modules on Employability and Entrepreneurship provided by Nestlé Philippines, Inc.

Description of Procedures:

- 1. The Activity is an inter-school competition that encourages students to apply the knowledge they learned from the modules on Employability and Entrepreneurship provided by Nestlé Philippines, Inc. to all the Senior High Schools in Region V Bicol.
- 2. The Activity will have two stages:
 - i. Division Level competition
 - ii. Regional Level competition
- 3. To confirm participation in the Division Level competition, interested public Senior high schools in Bicol region must submit a registration form and a duly signed parent consent and waiver form to the assigned Nestlé Needs Youth (NNY) school ambassador. The team that will represent the school must comply with the qualifications of Participants as stated in these mechanics. Only one team can represent the school.
- 4. In the division level competition qualified entries must have the following requirements:
 - a. The spoken poetry must be an original composition and should be in English only.
 - b. The piece must be related to the theme:

Competition Theme: "Pathways to Possibility: Navigating Careers and Creating

Opportunities"

Contestant will be given a maximum duration of 5 minutes to recite or deliver his/her piece through video recording. No deduction shall be made if the contestant finishes the delivery less than the maximum duration time.

- c. Sounds, instrumental or musical background are allowed to compliment the delivery. No deduction shall be made if the contestant opts not to have a musical background.
- d. Contestants shall register on or before 15 November 2024 and submit their division entry on or before 5:00 PM on 30 November 2024 to the designated NNY School Ambassador. Entries submitted beyond this time and date will not be entertained.
- 5. There will be one winner per division who will represent the division to the regional competition. Winning video entry in the division level competition will automatically move up to the regional level competition.
- 6. There will be three (3) regional winners (1 Champion, 1 First Runner-Up, and 1 Second Runner-Up). The Participating Teams in the Regional Level competition will be ranked based on their scores earned during the judges' deliberation.
- 7. Video submissions for the competition must be in .mp4 format, and must not show or feature persons other than the student. By participating in this Activity, the parent agrees to the participation of their child (the student) in accordance with the terms and conditions of this Activity.
- 8. A video submission for the division level of the Activity is considered one entry, Only one (1) entry per school is allowed.
- 9. Video submissions for the Division Level competition must:
 - a. not infringe any third-party rights;
 - b. not contain any illicit, inappropriate, and/or offensive content;
 - c. not contain any feature marks, logos or brand names other than Nestlé Needs Youth Logo.
 - d. comply with the guidelines/requirements of the Activity mechanics and terms and conditions.
- 10. By joining the Activity, a Participant / Participating Team represents and warrants that:
 - They are solely responsible for the video/s submitted and the consequences of submitting them as entries.
 - They video/s does/do not infringe any third-party rights.
 - The video/s is/are not offensive or obscene, nor does/do it/they promote racism, bigotry, hatred, harassment or physical harm of any kind against any group or individual, nor does/do it/they contain any inappropriate images which include but are not limited to nude, scantily clad photos and/or photos exposing private parts.
 - The video/s and the Participant's use thereof does/do not constitute an invasion of any person's right of privacy or publicity.

- The video/s does/do not violate or infringe any person's intellectual property rights, copyrights, trademarks, service marks, trade names, restricted material, trade secrets or other proprietary rights, or pose or create a security risk to any person.
- The video/s contain/s no malicious codes, including but not limited to, worms, trojan horses, viruses, cancelbots, time bombs, or other computer programs that might damage, intercept, interfere, or expropriate any program, system, data, or personal information.
- The video/s is/are not unlawful, nor does/do it/they facilitate the violation of any law or any applicable rule or regulation.
- 11. Participants / Participating Teams understand and agree that their personal information will be processed by NPI solely for the purpose of running the Activity and awarding the prizes, in accordance with NPI's privacy notice which can be found here: https://www.nestle.com.ph/info/privacypolicy

Description Of Winners:

1. The criteria for judging of Division Level Video Entries and Regional level face-to face competition will be as follows:

a. Content - 20%

- i. The content of the spoken piece is relevant and related to the theme.
- ii. The piece shall have a powerful and meaningful message to the audience

b. Delivery and Performance - 20%

- i. The spoken piece was delivered from the heart
- ii. Facial expression, hand and body gestures emphasized the different elements of the performance.
- iii. Voice is modulated, compelling and phrasing is fluent.
- iv. Spoke loudly and clearly enough for listeners to hear and understand
- v. Voice project confidence and conviction.

c. Convincing Aura - 10%

- i. Eye contact pulled the audience to the message of the spoken words.
- ii. Audience attention and interest were captured and sustained throughout the delivery
- iii. Enunciation is clear. Audience can understand what is being spoken.
- iv. Words are pronounced distinctly and correctly. Does not shutter nor stummer.
- v. Pronunciation and intonation sound natural.

d. Originality -30%

- i. Must be originally composed or written by the participants
- ii. The piece was effectively recited from memory
- iii. Freestyle or improvising was spontaneous even if a word or line was forgotten.

e. Attire - 10%

i. Attire compliments contestant's spoken piece.

f. Audience-10%

i. Connection to the audience was established from the heart.

TOTAL: 100%

- 2. The set of judges who will select the Division Level Winners and Regional Level Winners shall be determined by Nestlé Philippines, Inc. ("NPI") and/or its implementing agency. The judges will select the Division Level Winners and Regional Level Winners based on the above criteria and compliance with the Activity mechanics.
- 3. The qualification of the winners and their entries will be subject to verification by NPI in accordance with its procedures.
- 4. Regional Level Winners will be announced via a memorandum from the DepEd-Bicol regional office.
- 5. NPI reserves the right to publish and/or broadcast the winners' name, photo or likeness, and video submission/entry, for advertising and publicity purposes without further compensation to them.

Prizes To Be Won:

- 1. Winners will receive the following prizes:
 - a. Division Level Winner (One winner per Division)

 Champion prize package worth P5,000 + Certificate of Recognition
 - b. Regional Level Winners (total of 3 winners)
 - Champion prize package worth P20,000 + Certificate of Recognition
 - First Runner Up prize package worth P15,000 + Certificate of Recognition
 - Second Runner Up prize package worth P10,000 + Certificate of Recognition
- 2. The Prize will be delivered to the winning schools' address as provided in the registration form. NPI, through its implementing agency, will shoulder the delivery costs of the Prize. It will be delivered to the school on a date scheduled and agreed upon with the implementing agency, or within 60 days from the end of promo period.
- 3. By receiving the Prize, the Participant attests that they have read and understood the full Activity mechanics and agree to abide by the terms and conditions of the same.
