

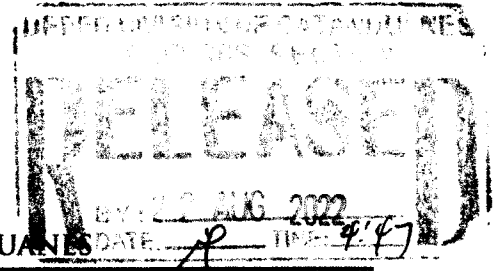

1. This pertains to the **Regional Memorandum No. 88 s.2022** with subject special work arrangement for DepEd teaching and non-teaching personnel who opted to be vaccinated with covid-19 vaccine.
2. Relative to this, all DepEd employees who opted to be vaccinated with COVID-19 vaccine will be excused from reporting to their respective post or offices for three (3) consecutive days (inclusive of Saturdays, Sundays, and Holidays) after vaccination. The day of the vaccination shall be considered as day 1. Furthermore, the very purpose of this is to minimize the Adverse Effect Following Immunization (AEFI) signs and symptoms that incur and further ensure the safety and well-being of the personnel.

In addition, for monitoring purposes, all personnel availing such special arrangement are hereby directed to attached photocopy of the vaccination card as supporting document/s in the submission of the Daily Time Record (DTR) to their respective Personnel Section. Pursuant to DepEd Regional Memorandum No. 76, s. 2021, entitled "Participation of DepEd Region V Employees in the Implementation of the National Deployment and COVID-19 Vaccination Program", and in preparation for the progressive expansion of Face to Face classes in all Schools Division Offices (SDO), all DepEd teaching and non-teaching personnel are encouraged to have their Primary doses and Booster shots of COVID vaccine through respective LGU- Health facilities.

Relative to this, all DepEd employees who opted to be vaccinated with COVID-19 vaccine will be excused from reporting to their respective post or offices for three (3) consecutive days (inclusive of Saturdays, Sundays and Holidays) after vaccination.
