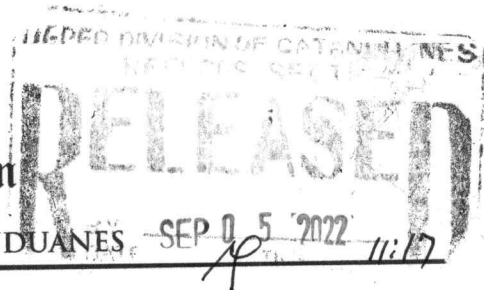

GOOGLE B-COOL (BOOTCAMP FOR CERTIFICATION AND OPPORTUNITIES FOR  
ORGANIZATIONAL LEVERAGING)**

1. The National Educators Academy of the Philippines Region 5 (NEAP-R5) and SDO Catanduanes is in support of the NEAP Flagship Program for Teachers 2022 dubbed the **Google B-Cool (Bootcamp for Certification and Opportunities for Organizational Leveraging)**.
2. The training package is anchored on PPST, and supports the Career Progression of Teachers and the Learning Recovery Plan of the DepEd Region V which seeks to formalize Teachers' Upskilling.
3. In this regard, the nomination is open for **60 scholars** to join the Bootcamp. Please be reminded of the eligibility requirements for registration in NEAP-recognized professional development programs based on DepEd Memorandum No. 82 s. 2020 Guidelines on the Registration of Teachers and School Leaders for NEAP-Recognized PDP and Courses.
4. The 60 slots shall be divided into 20 districts of this division. Public School District Supervisors or their designated personnel are directed to submit 3 names of qualified teachers using the attached form (*Enclosure A*) together with the Letter of Intent (to be accomplished by the teacher) to the SGOD-HRD Unit on or before September 7, 2022, at 5:00 PM.
5. If the district has no or an inadequate number of nominees after the due date NEAP Division Focal Person shall decide on the alternate.

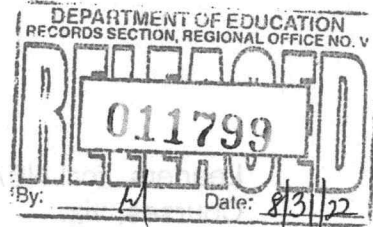

1. As established in DepEd Order No. 01 s. 2020 entitled Guidelines for NEAP Recognition of Professional Development Programs and Courses for Teachers and School Leaders, DepEd supports the Professional growth and lifelong learning of its Teachers and School leaders as key foundation to the upgrading of quality basic education.
2. To further amplify this streamlining effort of the Department, DepEd Region V thru the National Educators Academy of the Philippines-Region V(NEAP-R) in collaboration with NEAP-Office of the Director (NEAP-OD) rolls its Flagship Program for Teachers for 2022 dubbed as **Google B-Cool (Bootcamp for Certification and Opportunities for Organizational Leveraging)**. This Project is supported by Learning and Development Needs Assessment Results with over 27,000 respondents from all over the region.
3. The Training Package to be used in this Bootcamp is a NEAP-recognized Professional Development Program that is consistent with the Professional Development Priorities and anchored to the Philippine Professional Standards for Teachers. This supports not only the **Career Progression** of our Teachers but also the Learning Recovery Plan of the DepEd Region V which seeks to formalize **Teachers' Upskilling**.
4. In this regard, this Office announces the **Call for Nominations** for Sixty (60) qualified scholars for each division **on or before September 9, 2022**. The template for the endorsement letter is attached. SDOs through their Personnel Development Committee/ Learning and Development Committee are enjoined to strictly adhere to the following general eligibility requirements for registration in NEAP-recognized professional development programs and courses set in DM 082 s. 2020 (Guidelines on the Registration of Teachers and School

Leaders for NEAP-Recognized Professional Development Programs and Courses, viz:

*Teachers must:*

- i. be holding a permanent item
- ii. have no pending administrative, civil or criminal case;
- iii. have not been found guilty of any violation involving moral turpitude, corruption or fraud;
- iv. be willing to sign and commit to the provisions of the NEAP-recognized Professional Development Contract; and,
- v. be willing to prepare and undertake the conduct of a NEAP-PDP Action Plan

Furthermore, NEAP-R sets the following specific eligibility requirements:

*Teachers must:*

- i. be computer-literate, with Personal Laptop and amenable to conducting LAC sessions using the learned competencies in Bootcamp
- ii. willing to travel
- iii. willing to advocate the goals of Google B-Cool Project
- iv. willing to participate in different NEAP-R initiatives

5. The Bootcamp will run in thirteen (13) batches with sixty (60) scholars per batch at a date and venue to be announced in a separate issuance. To fully align the digital competency gaps, the Program Support Fund of the Project will cover all training expenses including registration, Google Certification Vouchers, Meals, and Accommodation of Scholars, while traveling expenses will be charged to their Local Funds subject to the usual accounting and auditing rules.
