- 1. Consistent with our commitment to providing professional development for teachers and school leaders, this Office thru the HRDD-NEAP R5 in collaboration with the NEAP-CO launched the massive professional development program for teachers last January 9-29, 2023. This program focusing on addressing digital gaps was dubbed as "Google B-COOL or Bootcamp for Certification and Organizational Leveraging." The training program trained more than 700 teachers representing thirteen (13) schools division offices across the region per Regional Memorandum No. 137, s. 2022.
- 2. One of the major requirements of the training program was to record/document the initial gains of the training effectiveness employing the Kirkpatrick evaluation model. This involved measuring the participants Daily Evaluation and End-of-Program Evaluation (Level 1-Reaction Level), and Pre-Test and Post-Test Results (Level 2-Learning Level).
- 3. To ensure the training objectives were fully achieved, another major requirement of each scholar/participant at the end of the training is to submit a Re-Entry Action Plan (Level 3-Behavior Level). This plan should focus on behavioral changes (Level 3) and aims to promote the integration of technology into education.
- 4. In this regard, all the Google B-COOL scholars are hereby directed to submit the following reports on or before September 12, 2024:
 - a) Upload the accomplishment reports to this link: https://tinyurl.com/gbcoolend with full documentation of the implemented REAPs/WAPs. These documents must be checked and

verified by HRDS of the respective SDOs and signed by the Head of Office; and

- b) Through the HRDS SEPS and EPS-II, submit the video portfolios of selected scholars at the Google Philippines Headquarters and to be uploaded to B-COOL Project Facebook Page and DepEd ROV Facebook Page on a specific date to be announced.
- 4. The uploaded Level 3 Accomplishment Reports will be consolidated, processed, and analyzed by HRDD-NEAP R5 in collaboration with Q Software Research Corporation and Google Philippines using the Level 3 Evaluation Report Template indicated in the DepEd Memorandum 44, s. 2023. The findings from this evaluation will be communicated to the National Educators Academy of the Philippines Central Office and will inform them of the ongoing efforts to continuously improve the quality of professional development for our teachers and school leaders in DepEd Region V.
