 - > Narrative reports are to be filed in the school as part of the MOVs of school activities under DRRM Programs.
 - > 4 photos must be printed at the back of the NSED Monitoring Template
 - > Please use 8.5" x 13" paper (Long Size)



6 PHASES OF EARTHQUAKE DRILL ALARM During the drill, the 2-minute alarm indicates earthquake or shaking. RESPONSE 2 Perform "duck, cover and hold". Remain in this position until the "shaking" stops. **EVACUATION** As soon as the shaking stops, immediately evacuate the school building and proceed to identified evacuation areas **ASSEMBLY** At the Evacuation Area, group the student together according to the class where they belong. **HEAD COUNT** Teachers should check and make sure all students are accounted for. **EVALUATION** An evaluation of the drill must be conducted to identify problems encountered during the drill and how these can be improved in future earthquake drills.

The NDRRMC Memorandum No. 013, s. 2024, dated 24 January 2024, outlined the schedule for the conduct of CY 2024 Quarterly Nationwide Simultaneous Earthquake Drill (NSED).

To allow for a more meaningful conduct of the Nationwide Simultaneous Earthquake Drill (NSED), the Third Quarter NSED is being moved from 12 September 2024 (09:00 AM) to 26 September 2024 (09:00 AM).

In this regard, all DRRM Councils at all levels and other agencies and constitutional bodies concerned are hereby enjoined to organize and conduct the above-mentioned activity as rescheduled using worst-case scenarios specific to their areas of responsibilities (AOR) to promote earthquake preparedness. Minimum public health precautionary measures must be observed.

After-Activity Reports and Participation Data Reports shall be submitted to email address: disasterpreparedness@ocd.gov.ph within twenty (20) working days after the activity for consolidation and submission to the Chairperson, NDRRMC.
