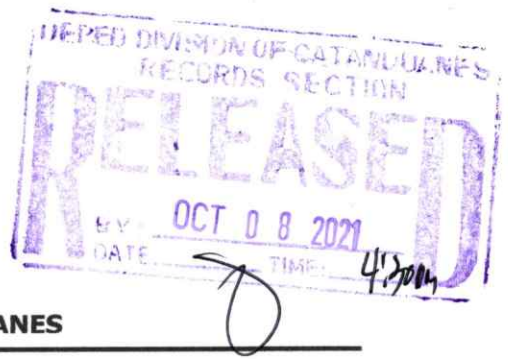

 - Learner's personal documents (any of the following: PSA/ NSO Birth Certificate; PSO/ NSO Marriage Contract; Voter's ID/ Voters certification; Baptismal Birth Certificate duly authenticated by the MCR; Barangay Certification)
- To ensure health and safety of all concerned, minimum health protocols shall be observed and complied within the duration of the activity.
- Travel and other related expenses of those involved shall be charged against Local Funds subject to the usual accounting and auditing rules and regulations.
