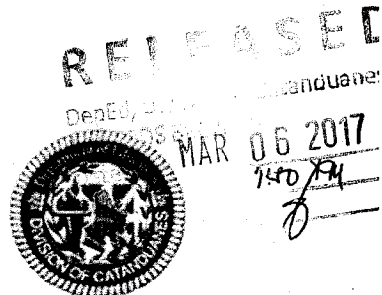

**DIVISION SHOWCASE OF BEST PRACTICES IN THE EARLY LANGUAGE LITERACY AND NUMERACY PROGRAM (ELLNP) IMPLEMENTATION**

1. In line with the implementation of The Learning Action Cell (LAC) as a K to 12 Basic Education Program School- Based Continuing Professional Development Strategy for the Improvement of Teaching and Learning as reiterated in DepEd Order No. 35, s. 2016, a Division Showcase of Best Practices in Early Language Literacy and Numeracy Program (ELLNP) shall be held on **March 27, 2017** at Rakkell Inn, Virac, Catanduanes.
2. Participants to this activity are the Public Schools District Supervisors, (PSDS) and identified one (1) pair of presenters, (1 LAC leader and 1 facilitator) of the school's LAC from K to grade 3 in each districts. There will be simultaneous presentation of the best practices in a powerpoint for the school head (LAC leaders) and key teacher (LAC facilitator).
3. The activity aims to :
  - a. benchmark schools best practices in the implementation of the ELLNP
  - b. recommend suggestions on how to improve ELLNP implementation of inputs in schools.
4. To identify the best presenter in the district which will be awarded during the activity, the PSDS shall screen and select the schools presenters using DepEd Order No. 35, s. 2016 highlighting evidences on "II – Policy Statement", pp. 2 to 3.
5. A registration fee of Php 300.00 will be charged each participant to defray expenses for the accommodation, a.m./p.m. snacks and lunch. Travel, registration fee and other incidental expenses shall be charged against school MOOE fund, while materials and supplies to the Division MOOE fund subject to the usual accounting and auditing rules and regulations.
