1. In compliance with DepEd Order No. 32 s. 2017 or the Gender-Responsive Basic Education policy which seeks to integrate the principles of gender equality, gender equity, gender sensitivity, non-discrimination, and human rights, in the performance of basic Education, this office will conduct a Division Training Writeshop and Development of Advocacy Materials with GAD-Curriculum Content.
2. The activity aims to:
