**MONITORING OF THE 8 - WEEK LEARNING RECOVERY CURRICULUM
 POST ASSESSMENT ACTIVITIES**

1. Pursuant to Regional Memorandum No. 127 s. 2022 re: Guidelines on the 8 - Week Learning Recovery Curriculum Post Implementation Assessment Activities, the Curriculum Implementation Division (CID) shall conduct the monitoring of the Post Implementation of the 8 - Week Learning Recovery Curriculum in elementary schools of the 20 districts.
2. The monitoring aims to assist schools in the efficient implementation of post assessment activities to:
 - determine how well the students have performed in the intervention;
 - gather information on how far the actual skills of the pupils with the expected skills for the grade level had been achieved; and
 - record and report the progress of the pupils to inform further instruction.
3. The Monitoring Personnel shall be guided by this schedule:

4. The monitors are advised to coordinate with the concerned Public Schools District Supervisors/In – Charge of the Districts especially on identification of schools for monitoring. They shall secure their travel authority prior to the field visit.
5. Monitoring reports for the 8 – Week Learning Recovery Curriculum post implementation shall be submitted to the CID Chief for consolidation and analysis.
6. Transportation expenses of monitors shall be charged to Division MOOE subject to the usual accounting and auditing rules and regulations.
