CONDUCT OF THE STATE OF THE LEARNERS GOVERNMENT ADDRESS (SOLGA) FOR FIRST QUARTER AND END OF SCHOOL YEAR 2024-2025

- 1. In compliance with OUPS Memorandum No. 2023-03 titled Interim Guidelines of the learner Government Program (LGP), this office, through the School Governance and Operations Division-Youth Formation Coordinators (YFC), remind all presidents of Supreme Elementary Government (SELG) and Supreme Secondary Learner Government (SSLG) on the conduct of the State of the Learner Government Address (SOLGA) for the First Quarter and for the end of School Year 2024-2025. X, Section 1.11, of OUPS Memo No.2023-03 the SELG/SSLG president shall conduct a (SOLGA) during the first and last quarter of the school year. All SELG/SSLG president shall conduct their SOLGA during the flag raising ceremony in their respective schools on a chosen date from October 14, 2024 to October 28, 2024. The SOLGA must highlight significant accomplishment on the following:
 - a. Promotion of DepEd Core Values in the School
 - b. Conducted Programs, Projects, and Activities as reflected in the action plan
 - c. Learner support activities conducted to assist learner-related outcomes
 - d. Resolutions/policy recommendations passed through the SELG/SSLG
 - e. Impact of SELG/SSLG activity to the Learner, School and the Community
 - f. Other accomplishments of the SELG/SSLG.
- 3. An accomplishment report following the DepEd template with photo documentation shall be submitted through email at yfd.ctd@deped.gov.ph one week before the end of School from March 1 31, 2025.
