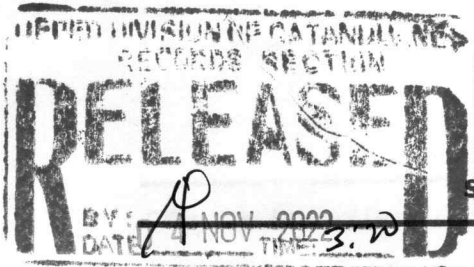

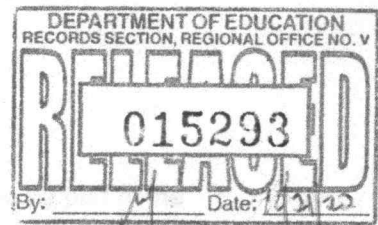

**2022 REGIONAL OBSERVANCE OF THE FILIPINO VALUES MONTH**

To: Schools Division Superintendents

1. Presidential Proclamation No. 479 entitled *Declaring the Month of November of Every Year as Filipino Values Month* was signed on October 25, 1994, by the late former President Fidel V. Ramos to create moral awakening and national consciousness on human values that are unique, genuine, and positively Filipino. With this declaration, Filipinos of all ages and from all sectors of all sectors of the society are enjoined to actively participate in this annual observance.
2. In compliance with presidential proclamation and ensure realization of its goal, the Department of Education (DepEd) Region V joins the nation in the celebration of the 2022 National Observance of the Filipino Values Month with the theme "**Magandang Kaugaliang Pilipino: Isabuhay at Pagyamanin Tungo sa Matiwasay at Maunlad na Kinabukasan**". This year's theme focuses on how Filipino values can contribute to nation-building and achievement of individual and national goals.
3. During the month-long observance, all schools, both public and private are encouraged to integrate the Filipino values in the teaching-learning activities, not only in Edukasyon sa Pagpapakatao (EsP) but also in all the different learning areas. Likewise, such values can also be incorporated in the activities of the different celebrations of the month, such as the:
  - \* National Children's Month;
  - \* Economic and Financial Literacy Week;
  - \* Global Warming and Climate Change Consciousness Week;
  - \* Araw ng Pagbasa;
  - \* National Week of the Gifted and Talented;
  - \* National Science and Technology Week;
  - \* other co-curricular activities
4. Below are the suggested activities in divisions, districts and schools in collaboration with stakeholders:
  - a. Hanging of advocacy tarpaulin;





- b. Showcase of Magagandang Kaugaliang Pilipino as part of the lessons;
  - c. Virtual symposium (Revisiting Filipino Values);
  - d. Promotion of Magagandang Kaugaliang Pilipino in schools, community and family;
  - e. Other theme related activities
5. Activities relative to the observance of the Filipino Values Month (FVM) shall be held in accordance with the DepEd Order No. 9, s. 2005, entitled Instituting Measures to Increase Engaged Time-on Task and Ensuring Compliance Therewith and DO No. 034, s. 2022, entitled School Calendar and Activities for the School Year 2022-2023.
6. Minimum public health standards shall be observed during the celebration of FVM.

**GUIDELINES ON THE DIVISION SEARCH FOR BEST FILIPINO VALUES MONTH IMPLEMENTING SCHOOL, SY 2022-2023**

1. The objectives of this search are the following:
  - a. to create a meaningful way of celebrating the Filipino Values Month in schools and at the division level providing an avenue for showcasing best practices; and
  - b. to provide an avenue for schools to benchmark unique practices.
2. The contest is open to all public elementary and secondary schools.
3. **Each municipality** is allowed to submit **1 entry for elementary** and **1 for high school only**. PSDS and school heads are requested to facilitate the municipal eliminations.
4. Entries shall be in a form of a **video presentation**. The duration is a **minimum of 5 minutes** and a **maximum of 7 minutes** per entry. Failure to comply with the time specified means disqualification of the entry. The **suggested resolution** of the video is 720p or 1080p. Salient information such as the title, school's name, etc. must appear on the **first part** of the video.
5. Rules on **copyright** must be strictly adhered to. The division shall not be liable for any concern regarding copyright issue.
6. The **suggested content** of the video are, but not limited to, the following:
  - a. Activities conducted in celebration of the Filipino Values Month;
  - b. Best/ unique practices of the school
  - c. Other contents which are deemed connected/relative to Filipino Values Month
7. The following criteria shall be followed:

<b>Criteria</b>	<b>Weight</b>
<b>Content</b> <i>(relevance to the theme, performance, story)</i>	40%
<b>Creativity</b> <i>(originality, impact, style, wow factor)</i>	30%
<b>Technical Quality</b> <i>(sound and music, video resolution, lighting, background, focus, over-all production)</i>	30%
<b>TOTAL</b>	100%

8. The deadline of submission of entries to the division level is on **December 2, 2022 at 5:00 p.m.** Video presentations must be submitted in a flash drive c/o Frankie T. Turalde, EPS in EsP.
