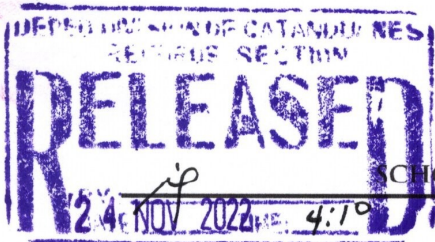

RESULTS OF THE FY 2021 NATIONAL QUALIFYING EXAMINATION FOR SCHOOL HEADS (NQESH)

1. The Department of Education (DepEd) through the Bureau of Human Resource and Organizational Development (BHRD), announces the **Results of the Fiscal Year (FY 2021) National Qualifying Examination for School Heads (NQESH)** which was successfully conducted through a remote online modality on July 31, 2022.

2. In determining the qualified examinees, the responses of the examinees were quantitatively analyzed employing the Rasch Model which is explained in DepEd Memorandum No. 100, s, 2002.

3. The table below describes the qualification status of DepEd Catanduanes takers depending on the Category rating:

Category	No. Examinees from SDO Catanduanes (19)	No. of Examinees (National)	Status
Category A	6 (31.57%)	2,203 (36.93%)	Eligible for the next stage for Principal I positions (such as interview and paper screening)
Category B	9 (47.36%)	2,096 (35.10%)	May take the next NQESH in 2023 after the provision of coaching and mentoring sessions with an experience/outstanding Principal. They shall be prioritized to be designated as Officer-In-Charge/Teacher-In-Charge in the case of deficiency of eligible Principal I applicants.
Category C	4 (21.05%)	1,667 (28%)	Must undertake an intensive School Heads Development Program (SHDP) through NEAP or authorized external service providers before they are allowed to retake the NQESH in 2024.
