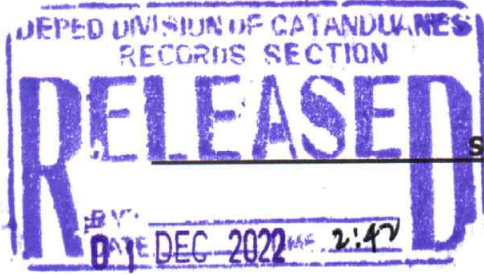

**DIVISION WORKSHOP ON PRODUCTION OF VIDEO LESSONS IN MUSIC, ARTS,

1. The Schools Division Office through the Curriculum Implementation Division shall conduct a Division Workshop on the Production of Video Lessons in Music, Arts, Physical Education and Health (MAPEH) on December 11-15, 2022. The venue will be announced later.
2. The workshop is a live-in activity. The participants may check-in at the venue on Day 0 – December 10, 2022 at 3:00 PM. Selected participants will participate on live-out.
3. The workshop aims to:
Create video episodes for MAPEH (pre-production and production).
Evaluate and edit submitted video lessons (post production).
Provide exposures to potential new members of production team.
Provide model localized/contextualized video lessons for SDO-Catanduanes according to set guidelines of DepEd -LRMDS.
4. Participants to this activity are; scriptwriters, production team, quality assurance team and safety health officer per enclosed list of participants.
5. Compensatory Overtime Credit shall also be given to school heads and non-teaching personnel. Enclosed herewith are the list of participants and Training Matrix for reference.
6. Participants are advised to bring the following:
 - a. Laptop
 - b. USB Flashdrive
 - c. Headphone
 - d. Extension wires
 - e. Condenser/mixer (if available)
