Warmest Greetings from Plan International Philippines!

We are glad to inform you that the Philippines was selected as a pilot for the implementation of Central Emergency Response Fund - Anticipatory Action (CERF-AA) for a Tropical Cyclone with target approximately 315,000 at-risk population. The pilot builds on the existing capacity of numerous organizations and networks already working on forecast-based financing while being at the same time deeply rooted in operational realities of responding to typhoons in the Philippines, including COVID-19 compounding effects.

The CERF Anticipatory Action Pilot for Tropical Cyclone is being implemented in Catanduanes covering four (4) municipalities – Virac, Bato, San Andres and Baras and five (5) municipalities in Northern Samar – Gamay, Catubig, San Roque, Mondragon and Catarman. The Action is being supported and in coordination with UN CERF secretariat and OCHA along with other participating UN agencies and strategic partners. The pilot AA project in Catanduanes and Northern Samar will be implemented by Plan International Philippines with close collaboration and coordination with UNICEF.

This action aims to support Schools and LGU's to have an enhanced capacity to plan, deliver and monitor coordinated multi-sectoral, gender-responsive, risk-informed approaches at scale to reduce stunting and other forms of malnutrition before, during and after an emergency.

Thus, Plan will be conducting a 1-day Capacity Building on Nutrition on Emergencies for Health and Nutrition Service Providers on December 5, 2022 at 8:00 in the morning until 4:30 in the afternoon to be held at Queen Maricel Inn, San Isidro Village, Virac, Catanduanes. The activity generally aims to capacitate service providers and partners to prevent the deterioration of nutritional status of the population particularly the vulnerable groups during emergencies.


