# CONDUCT OF ELECTIONS OF HOMEROOM PARENT-TEACHER ASSOCIATION, SCHOOL PARENT-TEACHER ASSOCIATION, AND MUNICIPAL/PROVINCIAL FEDERATED PARENT-TEACHER ASSOCIATION

TO: OIC-Assistant Schools Division Superintendent Chief Education Supervisors, CID & SGOD Public Schools District Supervisors/In-Charge of the Districts Public and Private Elementary and Secondary School Heads All Others Concerned

- 1. Pursuant to DepEd Order No. 13, s. 2022 titled "Omnibus Guidelines on the Regulation and Operations of the Parent-Teacher Associations", this Office reminds all Public Schools District Supervisors and School Heads to facilitate the conduct of election of the Homeroom Parent-Teacher Association (HrPTA), School Parent-Teacher Association (SPTA) and Municipal Federated Parent-Teacher Association (MFPTA) for SY 2025-2026.
- 2. The PTA Officers shall be organized by the School Heads and PSDSs following the schedules set below:

DATE	ACTIVITY	PERSON/S IN- CHARGE	
July 16, 2025 (within 30 days after the opening of classes)	Last day of HrPTA and SPTA Election	School Head/Teachers	
August 15, 2025 (within 60 days after the opening of classes)	Last day of Municipal Federated PTA Election	PSDS/In-Charge of the District	
August 20, 2025	Deadline of submission of Municipal Federated PTA Election Data to SDO	PSDS/In-Charge o the District	
August 30, 2025 (within 75 days after the opening of classes)	Last day of Provincial Federated PTA Election	Division PTA Coordinator	

3. The procedures of the PTA election are provided under Article 2 of DepEd Order No. 13, s. 2022 titled "Omnibus Guidelines on the Regulation and Operations of the Parent-Teacher Associations".

- 4. The School Heads, PSDS and PTA<sup>1</sup> Officers shall strictly observe the following provisions under DepEd Order No. 13, s. 2022:
  - 4.1 To distinguish from a parent-member of a PTA, a guardian may also be called the guardian-member of the PTA. Only individuals who are legally appointed as guardian by a competent court may serve as a PTA officer under these guidelines: Provided that, other individuals considered as guardians under Sections 5.1.1 to 5.1.4 hereof may vote and exercise all the rights of PTA members, except to be elected and appointed as officers of the HPTAs, GrPTAs, SPTAs, and FPTAs, or appointed as officers of any committee created under these guidelines, or as members of the ELECOM, SPIA-GC/FPTA-GC, and SPTA-DC/FPTADC.
  - 4.2 Parent Teacher Associations (PTAs) and their Officers are prohibited from engaging in any partisan political activity within the school premises or using the School PTA in any partisan political activity.<sup>2</sup>
  - 4.3 The PTA (Federated, School, Grade level, and Homeroom PTAs), as an organization or group formed, established, and/or recognized pursuant to these guidelines, shall not be used for any political activity and shall not engage in partisan politics in whatever form.<sup>3</sup>
