Implementation of the Roll-out of the Teaching of Philliealth

Learner's Material to Public Schools Nationwide

Pending the signing of the Memorandum of Agreement (MOA) between Department of Education (DepED) and PhilHealth, please be informed of the recent developments on the roll-out of our PhilHealth Learner's Material (PLM):

- A. Actual roll-out on the use of the PLM in public schools in your region shall be initially done in one (1) DepEd Schools Division only instead of region-wide. Please choose a DepEd Division Office in the region with a minimum of 20 but not more than 50 secondary schools.
- B. Activities for the roll-out includes:
  - Training on the teaching of the PLM which should include the following DepEd personnel:
    - Education Program Supervisor for MAPEH of the selected DepEd Division Office
    - MAPEH coordinators of schools in the selected DepEd Division Office
    - MAPEH teachers (maximum of 2) per school
  - Observation of actual teaching (at least 2 schools)
  - Exit conference with MAPEH coordinators
- C. To facilitate fund transfer to your PRO, kindly inform us of your chosen DepEd Division Office on or before April 12, 2017. Please see attached list of DepEd Division Offices in your region to guide you in the selection of the most appropriate roll-out site.
- D. Attached to this memo is the Certification issued by DepEd that the Learner's Material is compliant with the K 12 curriculum standards and is suitable for use in public schools nationwide. You may present the certification upon your coordination with your selected DepEd Division office in your region.
