DATE : **February 7, 2017**


1. In connection with Division CI training recently conducted last January 27-31, 2017 at Armenia Beach Resort, all Batch 2 CI trainees are advised to attend the coaching sessions which is scheduled every Thursday of the week at 1:00 pm -5:00 pm which will start on February 9, 2017 and end on July 7, 2017.
2. As per agreement during the Division Training on Continuous Improvement, the following guidelines were set:
 - a. The CI team composition cannot be changed nor replaced.
 - b. All CI team members must attend all scheduled coaching and plenary activities.
 - c. In the event that absence shall be made by a CI team member, he/ she shall not allowed to continue with the six (6) month course thus, will not be able to graduate except for reasons approved by the SDS.
3. The School CI team are required to meet at least once a week in the school level on a Regular basis during the six (6) months programs to intensively implement the submitted projects approved by the school heads.


