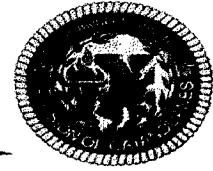



Subject: PROVINCIAL ORIENTATION- CONFERENCE AND ADMINISTRATION OF
THE ACCREDITATION AND EQUIVALENCY (A&E) TEST

Date: November 9, 2017

1. Pursuant to DepEd Memorandum No. 164, s.2017, entitled Accreditation and Equivalency (A&E) Test Registration and Administration, the Department of Education (DepEd), through the Bureau of Education Assessment (BEA) and this Office, shall administer the **Accreditation and Equivalency (A&E) Test for 2016 on November 19, 2017 at designated testing centers.**
2. The following may take the test:
 - a. Learners in the Alternative Learning System (ALS) and Non-Formal Education programs;
 - b. Out-of-School children and youth who are prepared for assessment; and
 - c. Adults who are seeking Certification of Learning.
3. Only registered applicants shall be allowed to take the test during the scheduled dates.
4. The passing rate is still 75% as per DepEd Order No.55, s.2016 entitled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program.
5. To ensure proper and standardized test administration, a **Division Orientation-Conference will be conducted on November 10, 2017, 1:00 o'clock in the afternoon at SDO- Conference Hall A.**

6. Authorized to attend the Orientation-Conference are the Room Examiners, Room Supervisors, Chief Examiners of testing centers and Registration Officer.
7. Attached is the List of Chief Examiners, Room Supervisors, Room Examiners and Testing Center in the conduct of (A&E) Test. They are enjoined to report to their respective assigned testing centers on or before 7:00 o'clock in the morning of November 19, 2017.
