**PILOT IMPLEMENTATION OF THE INTEGRATED LEARNING EXPERIENCES  
(ILE) IN THE EARLY GRADES**

1. In compliance with Regional Memorandum No. 656 s. 2023, Regional Guidelines for the Implementation of the Integrated Learning Experiences (ILE) in the Early Grades, Cabcab CES is identified as the pilot implementer of the said curriculum on November 20-December 1, 2023.

3. For two weeks, the trained early-grade teachers will execute the lessons and determine the appropriateness of the ILE learning resource package developed for implementation. Specifically, the teacher-implementers will focus on assessing the ILE components in the lesson maps and worksheets based on the Feedback Collection Tool given to them.

4. The Division ILE Coordinator, together with the Public Schools District Supervisor and School Head who have also been oriented on Integrated Learning Experiences, are also expected to closely monitor the pilot implementation of ILE in their respective areas using a monitoring tool.

5. A conference with the ILE Team will be conducted on November 15, 2023, at Cabcab CES to plan out the pilot implementation. Preparation of materials needed for the implementation of ILE will be done on November 18-19 and November 25-26, 2023.

6. Since the activity falls on a Saturday and Sunday, 4 day of service credit and 4 day of Compensatory Overtime Credit (COC) shall be granted to the ILE Team. This is in congruence to the provisions set under DepEd Order No.
