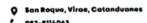

Further, an application submitted after 5PM on the set deadline shall be considered late but it will still be accepted, and shall be considered in the next vacancy/evaluation of position subject to the guidelines as provided in DepEd Order No. 7, s. 2023.

Any false and fraudulent document submitted shall be grounds for disqualification.

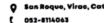

# CRITERIA AND POINT SYSTEM FOR HIRING AND PROMOTION TO NON-TEACHING POSITIONS

- The assessment for Non-Teaching positions shall be based on the following criteria:
  - Education units and/or degree relevant to the position to be filled, exceeding
    the minimum requirements as defined in the CSC-approved Qualification
    Standards (QS);
  - **b. Training** hours relevant to the position to be filled, exceeding the minimum requirements as defined in the CSC-approved QS, acquired after the last promotion but within the last five (5) years;
  - **c. Experience** relevant to the position to be filled, exceeding the minimum requirements as defined in the CSC-approved QS;
  - d. Performance based on submitted performance rating covering one (1) year or 12 months performance in the current or previous job or position relevant to the position to be filled;
  - e. Outstanding Accomplishments acquired after the last promotion;
  - f. Application of Education acquired after the last promotion;
  - g. Application of Learning and Development acquired after the last promotion; and
  - h. Potential measured using other evaluative assessments.

Consolidate daily time record (DTR) of school personnel and prepare monthly report of service (Form 7)  d. Monitor and record attendance/absence of school personnel and report to school head issues and concerns related thereto  e. Acts on application for leaves of school personnel and facilitate recommendation by the school head and approval by the SDS  f. Update vacation service/leave credits of school personnel and regularly communicate to all concerned  g. Maintain the confidentiality of personal information of school personnel to which he/she has legal access.  h. Coordinate with concerned offices, such as BIR, GSIS, PhilHealth, Pag-IBIG, CSC, and other agencies/entities on the implementation of policies and guidelines relevant to personnel.

- d. Prepare and submit HR-related reports to school head/HRMO
- e. Coordinate regularly with the HRMO in the implementation of HR policies and guidelines
- f. Facilitate submission and approval by the SDS of Permit to Study/Practice of Profession, Authority to Travel, and other school requests for school personnel.

# **Property Custodianship**

- Facilitate procurement of supplies, materials, equipment, etc of the school based on approved SIP/AIP or as directed by the school head.
- Ensure that supplies, materials, equipment, textbooks, and other learning resource materials are stored properly in a secured facility.
- c. Keep an updated inventory of all supplies, materials, equipment, textbooks, and other learning resource materials.
- d. Issue supplies, materials, equipment, textbooks, and other learning resource materials to requesting teaching and nonteaching personnel of the school.
- Prepare and submit reports on all property accountability of the school.

# General Administrative Support

- a. Assist the school head in the preparation of School Form 7 (SF 7)/loading of teachers.
- b. Assist the school planning team in the preparation of SIP/AIP.
- c. Provide general administrative support to school head and teachers like reproduction of learning materials, encoding of reports, preparation of documents, etc.
- d. Perform other functions as may be assigned by the School Head.

# Financial Management

- a. Assist the School Head on the preparation of the following documents such as but not limited to:
  - Cash disbursement register
  - Authority to debit/credit account
  - · Liquidation reports including supporting documents
- b. For IUs, assist the School Head on the preparation of required reports from COA, DBM, and other oversight agencies.
- c. Facilitate submission of all financial documents to the SDO and/or bank, if necessary.
- d. Provide assistance to other financial-related task of the School Head.
- e. Perform other functions as may be assigned by the School Head
