1. In line with the Implementation of Project ReCount Forward 5.0: Enhanced Reading and Numeracy Programs for Primary Learners pursuant to Division Memorandum No. 047, s. 2023, please be guided with the correction on the project title:

a. The updated title shall be “Project **Rea**Count Forward 5.0: Enhanced Reading and Numeracy Programs for primary learners.”

2. For reiteration, this Office will validate the preparation and files of the Profiles of Learners, Teachers and School Heads for reference and future recommendation. Final soft copies of the said profiles are sent to the Public Schools District Supervisors/In Charge of Districts.

3. Quality assured Formative Assessments in English, Mathematics, Filipino and Mother Tongue subjects are prepared and sent in links and soft copies in the official Messenger GC of the Public Schools District Supervisors by the Education Program Supervisors/Public Schools District Supervisors for easy access and distribution to all the elementary schools in SDO Catanduanes. The said formative assessments shall be conducted to determine progress and mastery of skills and domains targeted, however, the reading/numeracy teacher in charge of the program can also prepare similar formative assessments to address specific learning needs.

4. All grade leveled materials, activities in the lesson maps and other DepEd references may be utilized in the implementation of the program provided they target the skills and domains of the literacy and numeracy programs.

5. To ensure direction and effective implementation of the “Intervention Program Outside learning time” school heads are enjoined to regularly monitor the reading

and numeracy activities following the School Intervention Plan. A contextualized tool for progress monitoring shall be sent in the schools for consideration and reference. Chief Education Supervisors, Education Program Supervisors, Public Schools District Supervisors and SGOD Personnel are hereby directed to closely supervise the implementation of Project ReaCount Forward 5.0 following area of assignment and timeline. Education Program Supervisors in English, Mathematics, Filipino and the Public Schools District Supervisor in charge of Mother Tongue can supervise any schools in the Schools' Division Office with focus on the Top 20 schools with Full Refreshers.

6. As stated in the Division Intervention Plan, a culminating activity to show case progress and accomplishments of the learners included in the Project ReaCount Forward 5.0 shall be also the final and performance output of the learners in the program other than the progress in the formative assessments.
7. Expenses relative to the implementation of this project are charged to the local/MOOE funds subject to the accounting and auditing rules and regulations.
8. Attached is the Timeline of the activities as regards the implementation and the assignment of the Education Program Supervisors and SGOD Personnel.
