



## INVITATION TO BID

### CY 2021 BEFF- REPAIR AND REHABILITATION OF CLASSROOMS

- The *Department of Education, Schools Division Office of Catanduanes*, through the 2021 Government Appropriation Act (GAA) intends to apply the sum of **One Hundred Four Million Thirty Two Thousand Nine Hundred Ninety Five Pesos & 04/100 (Php104,032,995.04)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CY 2021 BEEF-Repair and Rehabilitation of Classrooms**. Bids received in exceed the **ABC** for each lot/cluster shall be automatically rejected at bid opening.

- The **DepEd, Schools Division Office of Catanduanes** now invites bids for the above Procurement Project. Completion of the Works is required **120 calendar days per Cluster**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184.
- Interested bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
- A complete set of Bidding documents may be acquired by interested bidders on **June 15- July 5, 2021** from given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (Php25,000.00) per cluster*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The Schools Division Office of Catanduanes will hold a **Pre-Bid Conference on June 22, 2021 at 9:00 AM at Conference Hall-A** through **face to face** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **July 5, 2021 at 9:00 AM at SDO- Conference Hall A**. Late bids shall not be accepted.
8. All bids must be accompanied by bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **July 5, 2021 at 9:00 AM at Conference Hall A/** at the given address below through **face to face**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Prior to Bid Opening, a representative of bidders should present and submit to the BAC a Letter of Intent and a Special Power of Attorney stating the detailed activities which he/she will perform relative to the bidding at hand.
11. The **DepEd, Schools Division Office of Catanduanes**, reserves the right to reject any and all bids, declare a failure of bidding, not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
