INVITATION TO BID

Extension of Feeding Days on the School-Based Feeding Program (SBFP) for NUTRITIOUS FOODS PRODUCTS for SY 2021-2022

1. The Schools Division Office of Catanduanes through the General Appropriation Act (GAA) CY 2021 intends to apply the sum of Two Million Four Hundred Thirty-Four Thousand Six Hundred Eighty Pesos Only (Php2,434,680.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Extension of Feeding Days on the Schools Based Feeding Program (SBFP) for Nutritious Foods for SY 2021-2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The winning supplier will deliver the foodpacks and milk to schools as dropoff points. Delivery time is 8:00 AM to 5:00 PM every Monday (for 5 days supply)

- 2. The Schools Division Office of Catanduanes now invites bids for the above Procurement Project. Delivery of the Goods is required ten (10) calendar days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *pass/fail* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.
 - b. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Prospective bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 26 to December 16, 2021 from the given address and website below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (Php5,000.00). The Procuring Entity shall allow the bidder to present proof of payment for the fees in person.
- The Schools Division Office of Catanduanes will hold a Pre-bid Conference on December 3, 2021 at 9:00 AM at SDO Lobby which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **December 16**, **2021 at 9:00 AM**. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on **December 16, 2021 at 9:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Prior to Bid Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand.
- 11. The Schools Division Office of Catanduanes reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
