SUBJECT: **IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR SCHOOL YEAR 2018-2019**

DATE: June 28, 2018

The Department of Education through the School Health Division, Bureau of Learners Support Services (SHD-BLSS) shall implement **School-Based Feeding Program this School Year 2018-2019**, with the new objective of improving of classroom attendance of greater than 85% per annum, as well as nutritional status of the school children.

It was noted that there are still some schools who have not submitted the **Baseline Nutritional Status report** and **Work and Financial Plan (WFP)** for the cash advance, despite the given deadline of June 25, 2018. Attached here is the list of the said schools.

Also, it was further reiterated that those schools with unliquidated cash advance to submit as soon as possible the Liquidation report c/o Accounting Section. **"No Cash Advance, No Start of Feeding Policy"** will be strictly implemented. In preparation of the feeding days, all schools must conduct a **School Orientation on SBFP** and submit a **Narrative report with Record of Attendance and Core Group composition**.

A partial Program Terminal Report (PTR) shall be submitted on or before **October 5, 2018** using the SBFP Form 5 Program Terminal Report.

To complete the 120 feeding days, the **START OF FEEDING will be on JULY 9, 2018, and will end at DECEMBER 14, 2018**. **Mid-weighing** shall be conducted after the 60 feeding days. And **Double Feeding** shall be done upon the approval of the Schools Division Superintendent and Regional Director.


