The Department of Education, Division of Catanduanes, through the 2019 Government Appropriation Act (GAA) intends to apply the sum of Eleven Million Eight Hundred Eighty One Thousand Two Hundred Ninety Nine Pesos & 31/100 Only (Php11,881,299.31) being the Approved Budget for the Contract (ABC) to payment under the contract for the project Repair/Rehabilitation of Division Office. Bids received that exceed the ABC shall be automatically rejected at bid opening.

The Schools Division Office of Catanduanes, through its Bids and Awards Committee (BAC) now invites bids for the project CY 2019 CORODO- Repair/Rehabilitation of Division Office. Completion of Works is required 180 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.

A complete set of Bidding documents may be acquired by interested bidders on <u>Dec. 9, 2019 to Dec. 30, 2019</u> from the address below and upon payment of the applicable fee of (Twenty Five Thousand Pesos) Php25,000.00 for the bidding documents, pursuant to the latest Guidelines issued by the GPPB.

The Schools Division Office of Catanduanes will hold a Pre-Bid Conference on <u>December 16</u>, 2019 at SDO, CID Office at 8:00 AM. which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before <u>December</u> 30, 2019. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on <u>December 30, 2019</u> at SDO, CID Office at 9:00 AM. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Prior to Bid Opening, a representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand.

The *DepEd*, *Division of Catanduanes*, reserves the right to reject any and all bids, declare a failure of bidding, not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
