A complete set of Bidding documents may be acquired by interested bidders on October 8 to 31, 2022 from given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (Php25,000.00) for every lot/cluster. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

- All bids must be accompanied by bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- Bid opening shall be on October 31, 2022 at 11:00 AM at SDO-CID Office. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Prior to Bid Opening, a representative of bidders should present and submit to the BAC a Letter of Intent and a Special Power of Attorney stating the detailed activities which he/she will perform relative to the bidding at hand.

The DepEd, Schools Division Office of Catanduanes, reserves the right to reject any and all bids, declare a failure of bidding, not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
